Applications are invited from retired DEOs for their re-engagement in the Headquarters Establishment of Panchayati Raj & Drinking Water Department on a contractual basis as OSD. The interested Retired DEOs may submit their applications as per Annexure-I latest by 27.06.2022.

2. Number of Vacancies to be filled up - 01 (One).

#### 3. Eligibility Conditions:

- i. Employees who have retired from Government service on attaining the age of superannuation and below the age of 65 (sixty-five) years having good service records and are physically fit shall be eligible for consideration for employment.
- ii. Employees against whom Departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during his service period will not be eligible for consideration.

#### 4. Selection Process:

i. Selection will be made through the Selection Committee constituted for the purpose.

#### 5. Tenure Terms & Conditions:

- i. The engagement shall be made initially for a period of one year only or till the existing vacancies are filled up on regular basis, whichever is earlier.
