- 1. Bidders not registered with Govt. of Odisha, should be registered under Odisha Govt. before the award of contract failing which the bid security shall be forfeited and the said bid stands cancelled.
- 2. The Bid documents shall be available in the website: https://tendersodisha.gov.in from 20.06.2022 at 05.00 P.M. The bid document can be downloaded from website for submission of the bid in the prescribed format by the intending bidder.
- 3. Bids shall be received only "online" on or before **30.06.2022 up to 05.00 P.M.** The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III or Class- III.
- 4. I) As the Bidders are exempted from depositing Bid security/ EMD as per Lr. 281 Dt.05.01.2022, they have to submit "Bid Security Declaration" in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents.
 - II) The Bidders shall transfer **online the cost of Bid Documents as mentioned** in **Col.4** of table above towards the cost of bid through a process as mentioned under DTCN.
 - III) As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule of rates.
 - IV) The Authority will not be held responsible for any technical snag or network failure during on-line bidding.
 - V) The successful bidder has to submit the differential cost (i.e Estimated Cost put to tender minus the quoted amount) as Additional Performance Security (APS) as per Notification No. 4559 dt. 05.04.2021 of works department as below:

The APS amount in shape of Demand Draft / Term Deposit Receipt pledged in favour of Divisional Officer within seven days, of acceptance of tender otherwise the bid shall be cancelled and the security deposit shall be forfeited and further proceeding for blacklisting shall be initiated against bidder.

- 5. Bids received online on due date and on time shall be opened at **11.00** A.M. on **02.07.2022** in the office of *Superintending Engineer, RWS&S Division, Nabarangpur* in the presence of the bidders or their authorized representatives who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 6. The successful bid must be accompanied with electronic receipt through payment gateway of designated banks such as SBI/ICICI/HDFC bank towards cost of Bid documents during online submission.
- 7. Bid documents consisting of attested copy of contractor license certificate / affidavits / Experience of executing similar nature of work & Construction of RCC OHT of capacity not below 50KL from an

officer not below the rank of Executive Engineer /GST Certificate, EPF, GST Clearance & PAN copy, No Relationship Certificate & Labour License must be uploaded in the web site.

- 8. **Minimum Eligibility: Criteria**: (i) The Firms/ Companies/ Registered Contractors should have successfully completed and commissioned works of similar type valuing not less (**30% of the estimated cost**) in any one financial year during the last Five(5) financial years. (ii)) The Firms/ Companies/ Registered Contractors should have annual financial turnover of not less than (**40% of estimated cost**) in any one financial year in construction works during last Five(5) financial years & the turnover need to be certified by chartered accountant
