Mode of Submission of tender: Tender must be submitted online only in [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in)

1. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
2. As per the Notification No.07556900012016-17254/W dated.05.12.2017 of Government of Odisha, Works department the bidders have to remit their **cost of tender paper online** through payment gateways of designated banks. The bidders with pending or failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC, the designated Banks shall not be held responsible for such pendency or failure. The cost of the bid document & EMD are as per the NIT. It will be carried out through a single banking transaction by the bidder for multiple payments like Cost of Tender Paper on submission of bids. Various payment modes like Internet Banking / NEFT/RTGS of Designated Banks and their Aggregator Banks as well can be accessed by the intending bidders. A single banking transaction by the bidder for multiple payments like Cost of Tender Paper have to be done on submission of bids.

4.0 **Minimum Eligibility Criteria :-**

Bidder shall fulfill the following Eligibility (Qualification) Criteria:

4.1 **Technical Criteria**

- 4.1.1 Bidder shall be manufacturer/Authorised dealer of MS Pipes.
- 4.1.2 The manufacturers should have valid Bureau of Indian Standards (BIS) license for marking ISI mark on their product for at least 5 (five) years from the Bid Due Date.
- 4.1.3 The manufacturer's MS pipes should have satisfactory performance in Indian Projects for at least three years from the Bid Due Date.
- 4.1.4 The authorised dealers must submit authorized dealership certificate from manufacturer covering the warranty period for supply of MS Pipes

• **Documents Required**

- Copy of the Valid BIS License of the product to be supplied.document/certificate in support of satisfactory performance of MS pipes in Indian Projects for at least three years shall be furnished duly certified by an officer not below the rank of Executive Engineer or appropriate authority.

4.2 **Financial Criteria**

- 4.2.1 Bidders should have annual financial turnover of not less than 40% of Estimated Cost in at least one year during last 5 (Five) preceding financial years. Inflation/Escalation @ 10% per financial year (on compound basis) shall be considered on the value of annual turnover of the preceding years.

Bidder shall furnish audited annual financial year statements i.e. balance sheets, profit & loss accounts, corresponding schedules and auditor's report as a part of published annual report in support of meeting the financial criteria as mentioned above.

**Escalation Factor (On Compound basis):**

Following enhancement/compounding factors will be used for the costs of works executed and the financial figures to a common base value.

5. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of price bids. If any Bidder/ Tenderer withdraws his bid/tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.

6. Bidder should not have been black listed by any Govt. /Govt. Undertaking on bid submission date. Self-Declaration Certificate by the bidder in the form of affidavit is to be submitted.
7. The Bidders who have in last 3 financial years applied for / are undergoing Corporate Debt Restructuring (CDR) / Strategic Debt Restructuring (SDR) or facing recovery proceedings from Financial Institutions or those are facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR) are not eligible for qualification. Self-declaration certificate by the bidder in the form of Affidavit is to be submitted.
