8. <u>Minimum Eligibility Criteria:</u>

- i) The Manufactures should not be black listed by any Govt./ Govt. undertaking for supply of DI pipes in India. (Self-declaration certificate shall be submitted by the manufacturer in the form of affidavit)
- ii) The manufacturers should have valid BIS license for making ISI mark on their product for at least 5 (five) years by last date of bidding.
- iii) The Manufacturers DI pipes and fittings are in satisfactory performance in Indian projects for at least three years.
- iv) The manufacturers should not be blacklisted/ debarred / disqualified with respect to the quality issues by any Government / Government undertaking as procuring entity for supply of DI pipes in India, in last three years from the date of submission of tender. (Self-declaration certificate shall be submitted by the manufacturer in the form of affidavit)

- v) Self-declaration certificate by the manufacturers in the form of Affidavitdeclaring that in last 3 financial years they have not applied for / are undergoing Corporate Debt Restructuring (CDR) / Strategic Debt are facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR)
- 9. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of price bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
