### Terms and conditions

1. The engagement will be for a period of one year or till filling up of the regular vacancy or till attaining the age of 65 years whichever is earlier subject to satisfactory performance.
2. The retired Officer, against whom a vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five years preceding his/her retirement, or is member of a political party will not be considered for re-engagement.
3. Consolidated remuneration of the re-engaged employees shall be as per para-3 of F.D.O.M No. 7022/F, dated 17.03.2018. The above remuneration is excluding the retired Govt. Servant's, Pension and T.I which he/she avails.
4. The period of re-engagement shall not be counted as Government service for the purpose of pension and any other retirement benefit.
5. The re-engaged Officers will continue as OSD, subject to their satisfactory performance. The re-engaged employee will abide by Conduct Rules,1957 applicable to the Government servants and shall be liable to be proceeded against for their misconduct as per the provisions under the Odisha Pension Rules,1992.
6. The re-employment can be terminated at any time by the appointing authority due to unsatisfactory performance by giving one month notice.
7. The engaged OSDs who has retired from the posts belonging to Group-A i.e Under Secretary, Deputy Secretary, Joint Secretary and Additional Secretary shall report to their respective Branch Officers in charge of the section. But the OSDs who has retired from the post of Section Officer and Desk Officer shall report to the Section Officer/Desk Officer in charge of the section.
