Circle responsible for award and execution of contracts in which his or her spouse's near relative (Defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an Officer in any capacity between the grades of Superintending Engineer and Junior Engineer/Assistant Engineer (Both inclusive).
- 8. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for period of two years after his retirement from Government Service without Government permission.
- 9. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of the APS in the rates as noted below in shape of NSC/ POTD/ Term Deposit receipt of any scheduled Bank duly pledged to Executive Engineer, Minor Irrigation Division, Bhanjanagar within seven days of issue of letter of acceptance(LOA) otherwise the bid shall be forfeited. - 11. The contractors who want to participate in the tender are to submit only one bid for any particular work. No extra cost towards CGST and SGST will be paid/ reimburse to the agency. The CGST & SGST amount will be recovered from the work bill as per applicable law from time to time.
- 12. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/Medium/Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
- 13. Bidders registered as S.C, S.T & P.H. contractor desiring to avail concession(s) /Price preference as per prevailing rules should apply for the same in writing in shape of Affidavit & upload necessary document and affidavit in support of their claim along with their bid, failing which their case will not be considered for availing concession/ Price preference as per the rule. No claim in this regard after opening of the bid will be entertained.
- 14. The authority will not be held responsible for any technical snag or network failure during on-line biding. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
