6. OBJECTIVE

POST MONSOON – OCTOBER, NOVEMBER &

DECEMBER

Baseline data collection will cover the components such as micro Meteorological data, Ambient Air Quality , Noise level, Water quality ,Soil quality ,Ecology ,Socio Economic data, Land usage& Hydrogeological data

Study area: study area will cover 10 km radius from periphery of the mine

a. Meteorological Data

Micro meteorological data will be collected by installing an auto weather monitoring station. The following meteorological parameters will be recorded by data logger for a comprehensive wind profile of the site.

- Wind speed,
- Wind direction,
- Temperature,
- Relative humidity,
- Rainfall

b. Air Environment

Ambient air quality data will be collected within 10 km radius covering the following parameters & adopting methodologies as per IS 5182 in the study area covering Ambient Air quality stations as per TOR using Respirable & Fine dust samplers at each station:

- Respirable Particulate Matter (PM10 & PM2.5)
- Sulphur dioxide
- Oxides of Nitrogen
- Carbon monoxide
- Silica in PM10

c. Noise Environment

Noise Levels will be measured at minimum of six locations in the study area. Noise levels will be collected at each location on 24 hourly basis for estimating the day and night equivalents

d. Water Environment

Water samples will be collected from Ground water and Surface water. The parameters will be analyzed as per IS10500 (Drinking water quality standard). The water samples will be collected from about ten locations in the study area once in REIA study period. The locations will be selected based

on the reconnaissance survey of the area. The parameters will be analyzed as per notification of MoEF&CC, GoI dated19th May ,1993 under Environment (Protection) Act, 1986.

e. Soil Survey

A minimum of 6 soil samples will be collected and analyzed for physico-chemical analysis including micronutrients.

f. Ecological data

Primary data will be collected through site visit covering the following

- Collection of primary data to understand baseline ecological status, important floristic and faunal elements, sensitive habitats and rare species; from field observations;
- Collection of data from local villagers about importance and status of plants and animals.
- Compare the data so generated with authentic past records to understand changes;
- Identification of sensitive locations or protected areas as per Wildlife Conservation and Protection Act, 1972.

g. Socio Economic Data

Primary Data: Primary data will be collected through a structured schedule covering all the categories of villagers like Scheduled Caste, Scheduled Tribe, and other castes in the village. Small farmers, Marginal farmers, Medium Farmers, Large farmers also will be considered for the study by interacting with village leaders, and Panchayat Presidents.

Primary Data collection will also include household and village profile survey covering questions about age and gender distributions, family structure (nuclear/extended) availability of institutions (schools, level of education). Current ethnicities and tribes land ownership, land use, availability and accessibility to health care centers(primary health care units, pharmacies) socio-cultural practices, political structure and administration, economic generating activities(agricultural sector, animal husbandry), infrastructure, resources and services (water supply, electricity, telecommunications, roads, sewerage disposal practices) livelihoods (skills levels, source of income, employment status, development needs and priorities (poverty, unemployment, sanitation)

Focused Group Discussions (FGD): Primary data collection includes collection of information from all stake holders about their opinion through participatory rural appraisal (PRAs) and Focused Group Discussions (FGDs). Information about basic infrastructure needs and prime needs of the villagers will be gathered listing out the current Government & Cooperative Society schemes being operated in the study area/ mandals

In addition to the above, data as per the standard and additional TOR will be collected.

h. Land Use

The existing land use pattern of the study area will be established through literature review, which includes District Census Handbooks and other secondary sources. This will be verified for its present status in the study area of 10-km radius around the mine. This will include a classification of land use with respect to the irrigated and un-irrigated agricultural land, forest, human settlements and sites of archaeological, historical and cultural importance. In order to cover all the above aspects, we envisage following:

1. Review of the Town and Village Directories of the Census Directorate for the concerned district and also through the study of the data obtained from the District Planning Officer.

- 2. The land use classification based on the latest satellite imagery will be procured and analyzed for the recent land use classification within the 10-km radius surrounding the mine.
- 3. The land use pattern (from Census Reports) in the 10 km radius study area will be categorized conforming to the norms of Ministry of Food and Agriculture, Government of India, which maintains land records under following five categories:
 - Forests:
 - Land irrigated by source-covers agricultural lands;
 - Non-irrigated agricultural land-covers agricultural and fallow land;
 - Cultivable wasteland-includes land available for cultivation whether or not taken up for this purpose e.g. land under thatching grasses, bushes and other grooves for fuel, grazing lands etc.:
 - Land not available for cultivation-includes barren, uncultivable land, land put to non-agricultural uses like buildings, roads, railways, rivers, canals etc.;
- 4. A study area map will be prepared for the study area of 10 km radius around the project site. This map will depict all the broad physical features In addition to these, this map will also depict details like roads, railway lines, location of human settlements, rivers, places of tourist / archaeological / cultural importance / National Park / Sanctuary / Bio-sphere reserves from the Survey of India Topo Sheets.

i. Hvdro-Geological Studies

Basic level of hydro geological studies required for getting environment clearance needs to be taken up through analysis of secondary data from available literature and compiled from Irrigation Department, State and Central Ground Water Board (SGWB and CGWB), Agriculture Department, Public Health Engineering Department (PHED), India Meteorological Department (IMD), Geological Survey of India (GSI) etc. The data generation would mostly cover the following items:

- a. Hydro-geological conditions, catchments and flood history;
- b. Inventory of surface and ground water;
- c. Monthly, annual and peak precipitation;
- d. Inventory of water use.

This needs to be done for the three mines in line with the requirements of Central Ground Water Board for necessary approval for availing NOC for dewatering from mine.

II. ENVIRONMENTAL IMPACTS

Environmental impacts will be listed and quantification of impacts will be done for environmental components relevant to the project. The identified impacts will be quantified using EPA approved AERMOD model for air quality. In case of water, land, biological and socio-economic environments the quantification/ predictions have been made based on standard methodology, scientific knowledge and experience.

III. ENVIRONMENTAL MANAGEMENT PLAN

The Environmental Management Plan, Risk Analysis and Disaster Management Plan will be prepared as per the guidelines of CPCB and MoEF&CC, GoI. Necessary Post project monitoring will be highlighted.

IV. OTHER STUDIES

The following other studies based on the project will be carried:

- Traffic studies
- any other special studies other than standard TOR

D. PUBLIC HEARING

Executive summary in English and local language will be prepared and necessary copies will be provided to SPCB for conducting the Public Hearing. Bidder would facilitate at SPCB to get suitable date, time & venue for public hearing, necessary newspaper publication.

Presentation on Technical aspects of the project will be made by consultant as support during the Public Hearing. Bidder will help to get the Proceedings of Public Hearing forwarded to MoEF&CC, GoI at the earliest.

E. EAC PRESENTATION

Detailed presentation as per MoEF & CC, GoI will be prepared and the same will be presented to proponent and EAC. Required copies of presentation material will be prepared and circulated by the bidder to EAC members.

F. SUBMISSION OF CLARIFICATION

Replies to the Clarifications on the points of EAC will have to be prepared and the same will be presented to EAC if required.

10. COMPLETION PERIOD

18 months from the date of award of the contract/release of order or LOI.

11. SUBMISSION OF DOCUMENTS

All documents as specified in Section (5) will be prepared and submitted by the bidder to MoEF&CC, GoI ,SEIAA, CPCB, SPCB, District Collector, District Industry Center, Gram Panchayat office etc. accordingly as per requirement. In addition, two copies of final documents should also be provided to Directorate of Mines, Govt. of Odisha.

- g) If the consultant fails to provide the quality services as envisaged under this Contract. The Consultancy Monitoring Committee (CMC) formulated to monitor the progress of the assignment may make judgment regarding the poor quality of services, the reasons for which

- shall be recorded in writing. The CMC may decide to give one chance to the consultant to improve the quality of the services.
- h) If, as the result of Force Majeure, the Consultant is unable to perform a material portion of the Services for a period of not less than sixty (60) days.
- i) If the "Employer", in its sole discretion and for any reason whatsoever, decides to terminate this Contract. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.
- 19.3. The documents including this RFP and all attached documents, provided by the Authority are and shall remain or become the properties of the Authority and are transmitted to the Bidders solely for the purpose of preparation and the submission of a Bid in accordance herewith. Bidders are to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Bid. The provisions of this Clause shall also apply mutatis mutandis to Bids and all other documents submitted by the Bidders, and the Authority will not return to the Bidders any Bid, document or any information provided along therewith.
- 19.4. The Authority reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP. Any such verification or lack of such verification by the Authority shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Authority there under.

20. ACKNOWLEDGEMENT BY BIDDER:

- 20.1. It shall be deemed that by submitting the Bid, the Bidder has;
 - 20.1.1. made a complete and careful examination of the RFP.
 - 20.1.2. received all relevant information requested from the Authority.
 - 20.1.3. accepted the risk of inadequacy, error or mistake in the information provided in this RFP or furnished by or on behalf of the Authority relating to any of the matters referred to in this RFP; agreed to be bound by the undertakings provided by it under and in terms hereof.
 - 20.1.4. satisfied itself about all matters, things and information including matters relating to the project site necessary and required for submitting an informed Bid, execution of the Project in accordance with the Bidding Documents and performance of all of its obligations there under; and acknowledged and agreed that inadequacy, lack of completeness or incorrectness of information provided in the Bidding Documents or ignorance of any of the matters relating to the project shall not be a basis for any claim for compensation, damages, extension of time for performance of its obligations, loss of profits etc. from the Authority, or a ground for termination contract agreement.
- 20.2. The Authority shall not be liable for any omission, mistake, or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the RFP or the Bidding Process, including any error or mistake therein or in any information or data given by the Authority

21. CONFLICT OF INTEREST

A Bidder shall not have a conflict of interest (the "Conflict of Interest") that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority shall forfeit 100% (one hundred percent) of the value of Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damage payable to the Authority for, inter alia, the time, cost and effort of the

Authority, including consideration of such Bidder's proposal, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise. Without limiting the generality of the above, a Bidder shall be deemed to have a Conflict of Interest affecting the Bidding Process, if:

- 21.1. such bidder or any Affiliate, Parent or Subsidiary Company thereof receives or has received any direct or indirect subsidy, grant, concessional loan or subordinated debt from any other Bidder or Affiliate, Parent or Subsidiary Company, or has provided any such subsidy, grant, concessional loan or subordinated debt to any other Bidder or any Affiliate or Parent or Subsidiary Company thereof; or
- 21.2. such bidder has the same legal representative for purposes of this Bid as any other Bidder; or
- 21.3. such bidder, or any Affiliate, Parent or Subsidiary Company thereof has participated as a consultant to the Authority in the preparation of any RFP document, design or technical specifications of this assignment.
- 21.4. Notwithstanding anything stated herein, a conflict-of-interest situation arising at the Qualification will be considered to subsist only, as between such Applicants attracting conflict of interest provisions on account of shareholdings, who submit bids under this document.

22. FRAUD AND CORRUPT PRACTICES

22.1. The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process and subsequent to the issue of the LOI and during the subsistence of the Contract Agreement. Notwithstanding anything to the contrary contained herein, or in the LOI or the Contract Agreement, the Authority may reject a Bid, withdraw the LOI, or terminate the Contract Agreement, as the case may be, without being liable in any manner whatsoever to the Bidder, as the case may be, if it determines that the Bidder, as the case may be, has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process. - 24.3.3. the financial quote is included, directly or indirectly, in the Technical Proposal or any document accompanying the Technical Proposal.
- 24.4. Such misrepresentation / improper response shall lead to the disqualification of the Bidder. If such disqualification/ rejection occurs after the Bids have been opened and the Lowest Bidder gets disqualified/ rejected, then the Authority reserves the right to annul the Bidding Process and to invite the fresh Bids.

The Authority may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or the authority or as may be required by law or in connection with any legal process.

27. VALIDITY OF BIDS

The Bids shall be valid for a period of not less than 90 days from date of opening of technical proposal. The validity of Bids may be extended subject to a maximum period of 120 days by mutual consent of the respective Bidders and the Authority.

28. BID SECURITY/EMD

- 28.1. All proposal submitted in response to the RFP document must be accompanied by an Earnest Money Deposit (EMD) of Rs.1,00,000/- (Rupees One lakh only) in the form of Bank Demand Draft drawn in favor of Director of Mines, payable at Bhubaneswar, Odisha from any Nationalized Bank and payable at Bhubaneswar, Odisha, Bids submitted without EMD will be rejected.
- 28.2. The Bid Security shall be returnable no later than 60 (Sixty) days from the Bid Validity Date except in the case of the Selected Bidder whose Bid Security shall be retained till it has provided a Performance Security under the provisions of Draft Contract Agreement.
- 28.3. The Authority shall be entitled to forfeit the Bid Security as Damages inter alia in any of the events specified herein below. Supporting documents and printed literature furnished by the Bidder with the Bid may be in any other language provided that they are accompanied by true translations of it in the English language, duly authenticated and certified by the Bidder. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Bid, the English language translation shall prevail.

29.2. Format and signing of Bid:

- 29.2.1. The Bidder shall submit the Bid in the format specified at Appendix-I, together with all the documents specified hereunder. The formats given is the minimum requirement and the Bidders shall furnish all the relevant details necessary to ascertain the technical and financial capabilities of the bidder as well as the detailed technical and business plan for implementation of the project proposed by the bidder.
- 29.2.2. The Bidder shall submit the Financial Bid by duly filling up the BOQ in the prescribed forms in the Appendix in sealed envelope to Director of Mines by the due date & time.
- 29.2.3. Bidders should attach clearly marked and referenced continuation sheets in the event that the space provided in the prescribed forms in the Appendix is insufficient. Alternatively, Bidders may format the prescribed forms making due provision for incorporation of the requested information.
- 29.2.4. Information supplied in the Bid, shall pertain either to the Bidder or to the Bidder's Affiliate or Parent or Subsidiary Company named in the Bid and not, unless specifically requested, to other associated companies or firms.
- 29.2.5. The Bidder shall provide all the information sought under this RFP. The Authority will evaluate only those Bids that are received in the required formats and complete in all respects. Incomplete and /or conditional Bids shall be liable to rejection.

The rates and prices quoted by the tenderer shall be inclusive of all works, tasks, studies, all other Subsidiary or Complementary Statutory clearances from the required statutory authorities, all taxes, levies, duties etc. No extra cost under the head of facilitation cost shall be entertained.

30. MODIFICATIONS/ SUBSTITUTION/ WITHDRAWAL OF BIDS

31. BID OPENING

32. TECHNICAL EVALUATION

32.1. The Authority will carry out evaluation of the Bids through a Bid Evaluation Committee constituted by it at its sole discretion. The Committee will proceed with evaluation process as detailed hereunder.

32.2. Stage 1: Pre-Qualification

- 32.2.1. On opening of the bid, the Authority will ensure that the Bid is accompanied by Tender fee/Cost of the Bid Document and Bid Security, as specified. - 32.3.8. After technical evaluation, financial proposals of the technically qualified Bidders shall be opened.

33. FINAL BID EVALUATION:

Financial bids of only those bidders who have been declared technically qualified by the committee as per the above stated procedure shall be opened for further evaluation and ranking. Final Bid will be done following Quality and Cost Based Selection (QCBS) criteria. Under QCBS selection, the technical proposals will be allotted weightage of 70% (Seventy percent) while the financial proposals will be allotted weightages of 30% (Thirty per cent). Proposal with the lowest cost amongst the technically qualified shall be given a financial score of 100(Hundred) and other proposals given financial scores that are inversely proportional to their prices w.r.t. the lowest offer. 34. SELECTION OF BIDDER

- The highest ranked Bidder with the highest marks obtained shall be awarded with the project.
