### Calling for willingness for the Physical Test (2<sup>nd</sup> Round) for the post of Forest Guard & Excise Constable only under CRE-2021 for Group 'C' Posts

In pursuance of the Advertisement No. IIE-121/2021-999(C)/OSSSC dt.30.09.2021 and Notice No. IIE-29/2022-124(C)/OSSSC dt.18.05.2022 for the Combined Recruitment Examination-2021 for Group-C posts, the Physical Test comprising of Physical Standard Measurement (PSM) and Physical Efficiency Test (PET) for the post of Forest Guard and Excise Constable were taken up from 26<sup>th</sup> July, 2022 onwards for the candidates shortlisted/screened on the basis of their performance in the written test.

2. The number of candidates qualified in the PSM & PET are not sufficient to fill up the vacancies for the post of Forest Guard and Excise Constable. The Commission has been pleased to conduct another round of Physical Test for both the posts to fill up the vacancies after shortlisting candidates from among the candidates placed in the Provisional Master Merit list of CRE-2021. The candidates who have earlier been shortlisted & called for the Physical Test shall not be considered again.

3. Candidates interested for the aforesaid posts having minimum physical standards are required to indicate their willingness online for either one or both the posts (as per eligibility) afresh to appear for the Physical Test comprising of Physical Standard Measurement (PSM) and Physical Efficiency Test (PET) by 17<sup>th</sup> August 2022. On receipt of willingness, the Commission will prepare a 2<sup>nd</sup> screening list of candidates to be called for Physical Test.

The candidates are advised to go through the minimum requirements of Physical Standards for each post and to opt accordingly only if they possess the minimum required Physical standard failing which they shall be disqualified at the first instance and shall not be allowed to participate in the Physical Efficiency Test (PET). The minimum requirement for the events is reiterated in brief for ready reference as under.

#### 4. PSM & PET for Forest Guard

(i) The applicants for Forest Guard must have the minimum physical standard of Height and Chest as detailed below:

NB: Three chances shall be allowed successively to clear Rope Climbing, High Jump and Long Jump. Failure to clear any of the event shall lead to disqualification of the candidate, then and there from that stage as per the norms prescribed in the advertisement / recruitment rules.

6. The preference for posts already given during the filing of online application shall not be considered for the purpose.

7. Those who do not give their willingness for any of these posts shall not be considered any further in the process of recruitment. No further claims shall be entertained in this regard.

8. The option exercised by the candidates online now indicating their willingness to participate in the Physical Test for Forest Guard and Excise Constable or both shall be final. Mere exercise of willingness by the candidates for the post will not confer any right for appointment. The 2<sup>nd</sup> screening list shall be drawn on the basis of merit and option exercised by the candidates. The candidates of the 2<sup>nd</sup> screening list shall not be considered for the posts of SFS, ARI & Amin.

To exercise option for willingness for Physical Test for the post of Forest Guard and Excise Constable, interested candidates shall have to visit the web portal and click the link the 'Applicant Menu' followed by 'EXPRESSION OF WILLINGNESS' etc. This is will be automatically closed online beyond the datelines.
