1st Corrigendum to e-Procurement Notice No- CCE,UIIP-01(01-08)/2022-23, Dt. 30.08.2022

1. The Bid Capacity Clause should be added as follows for all the 08 (Eight) number of works of the above e-Procurement Notice

To qualify for award of contract each Bidder who meets the minimum qualification criteria will be qualified only if his available bid capacity is more than the amount put to tender. The available bid capacity will be calculated as under:

Assessed Available Bid capacity = (A*N*2 - B)

Where,

A = Maximum value of the turnover of the bidder in any one year during the last five years updated by giving 10% simple weight-age per year to bring it to the present 2022-23 price level.

N = Number of years prescribed for completion of the work for which bid is invited.

B = Value of existing commitments of on-going works to be completed during the period of completion of the project up dating to the current year 2022-23 by giving 10% simple weight-age per year.

2. The Annual Turnover Criteria for the following works of the above e-Procurement Notice should be read as follows (Refer Section-2- Information & Instruction to Tenderers- General Instruction to Contractors- Clause- 9(a) of DTCN.

CCE,UIIP-01(08-08)/2022-23	Improvement of Service Road with Black Topping of Chhuriagarh Branch Canal from RD 00Km to 30.690 Km (working RD 00 to 20.527Km).	Should be read as 14.51 Crore instead of NIL.

These documents will be sent to the same competent authorities to check the authentication & if found incorrect/misleading necessary action as per codal provision shall be taken against the bidder.
