Programme for conduct of 2nd Round Physical Test for the post of Excise Constable & Forest Guard under the Combined Recruitment Examination-2021 for Group-C posts

In partial modification of this Commission's Notice No. IIE-42/2022-285(C)/ OSSCC dt.19.08.2022 and in pursuance of the Advertisement No. IIE-121/2021-999(C)/OSSCC dt.30.09.2021, Notice No. IIE-29/2022-124(C)/OSSCC dt.18.05.2022 and in continuation to Notice No. IIE-42/2022-268(C)/OSSCC dt.06.08.2022 for the Combined Recruitment Examination-2021 for Group-C posts, the Commission have been pleased to decide that the 2nd round Physical Test comprising of Physical Standard Measurement (PSM) and Physical Efficiency Test (PET) for the post of Excise Constable and Forest Guard will be held **from 14th September to 17th September 2022** in all the districts instead of 5th September 2022 in view of the post flood situation, Ganesh Puja and Nuakhai Festival of Western Odisha.

The number of candidates qualified in the PSM & PET in the first round of Physical Test held in July-2022 are not sufficient to fill up the vacancies for the post of Excise Constable and Forest Guard. The Commission has been pleased to conduct the 2nd round of Physical Test for both the posts to meet the shortfall of qualified candidates to fill up the vacancies after shortlisting candidates from among the candidates placed next in the Provisional Master Merit List of CRE-2021 on the basis of the willingness filed by candidates online.

Accordingly, candidates have been provisionally shortlisted @ 10 times of the vacancies for Excise Constable and @ 2 times of the vacancies for Forest Guard over and above the candidates allowed to appear the 1st round Physical Test vide No. IIE-42/2022-216(C)/OSSCC dt.12.07.2022. The list of candidates shortlisted for the 2nd round Physical Test prepared in order of merit is hereby published as the **2nd Screening List** in the web portal. The Roll numbers of such candidates who are provisionally allowed to appear in the 2nd Round PSM / PET is also published in the web portal as Annexure-I & II.

Admission letters for the purpose have been uploaded in the Commission's web portal. The details of the schedule of events and venue are available in the admission letter. The candidates may download the Admission Letters by logging in the Commission's web portal with their User ID and Password to appear the Physical Test.

No hardcopy of Admission Letter will be sent to any candidate by post.

The candidates are advised to visit the website of the Commission at regular intervals for updates.
