- 6. The bidders may submit their bid by post in the concerned present office address mentioned above.
- 7. The sealed bid should reach before the officers mentioned above within the above scheduled date and time. The bid received beyond the date and time will not be entertained. The department will not take any responsibility for postal delay.

- 8. The bidder should clearly mention his present address with PIN Code and contact no. in his bid paper & enclose the Security Money noted under Table at Col. No.4 in shape of Bank Deposit of any Nationalized Bank payable at Keonjhar duly pledged in favour of the **Executive Engineer, M.I. Division, Keonjhar.**
- 9. The Security Money will be returned to the unsuccessful bidder after finalization of the bid process.
- 10. The cost of quotation paper amounting to **Rs. 400.00(Non-refundable)** in shape of Demand Draft drawn in favour of **Executive Engineer, M.I. Division, Keonjhar** payable at Keonjhar will be submitted by the bidders at the time of purchase of tender papers.
- 11. The bidder can inspect the vehicle at the place mentioned in the table at columns No.7 during the office day and hours.
- 12. The bidder should write clearly their bid amount both in figure and words. Any difference in between the figure and words, the amount written in words will be taken in to account.
- 13. The successful bidder will have to deposit the full bid amount in shape of cash or Bank Draft of any Nationalized Bank payable at Keonjhar in favour of Executive Engineer, M.I. Division, Keonjhar.
- 14. If the successful bidder will fail to deposit his offered amount the security money deposited with his bid will be forfeited without assigning of any reason.
- 15. The vehicle/SR materials will be delivered to the bidder from the places of delivery mentioned in the table at Col.7.
- 16. The authority reserves the right to accept/ reject any or all the bids without assigning any reason thereof.
- 17. As soon as the full amount of the bid money is paid by the bidder he would acquired his lien on the auctioned materials and it will be his responsibility to look after such vehicle at his own expenses and the Department will not be responsible for any damage done by way of pilferage and any other unforeseen calamities and no claim on his account shall be entertained.
 - 18. The vehicle shall be removed from the site by the bidder within seven days from the date of issue of order at his own cost and responsibility. In case the vehicle is not lifted within seven days ground rent @ 1% of the bid amount for each day or delay will be charged. In the event of ground rent recoverable from the purchaser exceeding the sale price deposited the purchaser will cease to have any lien of the auctioned materials. The amount deposited towards the sale price will be adjusted towards ground rent and the auctioned materials will remains the absolute property of Government.
 - 19. The GST as applicable will be borne by the successful bidder/ auction purchaser and the receipt in support of deposit of GST to be produced before lifting the materials.
