Bids should be submitted by the eligible class of contractors as mentioned below, registered with the State Governments and contractors of equivalent grade/ class registered with Central Government/ M.E.S./ Railways through On-line in the Government web-site www.tendersodisha.gov.in. The bidders should have necessary portal enrolment (with own digital signature certificate). The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the Odisha State Government within a month of acceptance of bid. The bidders registered outside the Odisha State are required to submit an undertaking in the form of an affidavit that they are not registered under the GST Act in the State of Odisha as they have not started any business in the State and they have no liabilities under the Act. Such bidders have to produce VAT clearance certificate in the form VAT-612 alongwith

Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award to work/ signing of the agreement as per prevalent registration norms of the State failing which the bid security shall be forfeited the bid stands cancelled.
- 3. Bid shall be received only "on-line" on or before **Dt.20.09.2022** up to 17.00 hours. The bidders desirous to participate in bidding must posses compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
- 4. A pre bid meeting shall be held on Dt. 28.09.2022 at 11.00 hours at the office of Executive Engineer, RWS&S Division, Angul :at: Talcher to clarify the issues and to answer question on any matter that may be raised at that stage as stated in Clause 9.2 if the bidding document i.e. 'Instruction to Bidders'.
- 5. Bid must be accompanied with electronic receipt through payment gateway of designated banks such as SBI/ ICICI/ HDFC bank for bid security and cost of bid documents as specified for the work in the table along with bid documents during on line submission vide Office Memorandum No. 17254 dated 05.12.2017 of Works Department, Govt. of Odisha.

- N.B: In the event of the specified date of bid opening being declared a holiday for the officer inviting the Bid, the bids will be opened at the appointed time on the next working day.
- 9. Bid documents consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the work is available in web-site and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. - 10. Minimum Eligibility Criteria: (i) The Firms/ Companies/ Registered Contractors should have successfully Completed & Commissioned Works of similar type valuing not less (30% of the estimated cost) in any one year during the last 5(five) years. However, such similar type of work must be Completed & Commissioning of at least one Elevated Service Reservoir with equal to above 1,00,000 Itr capacity with 12 mtr RCC staging. The firm shall have to submit the performance certificate of the works constructed by them for satisfactory performance from appropriate authority i.e. not below the rank of Executive Engineer/ equivalent. Weightage @10% per year shall be given on the value of the completed work in the preceding years.
  - (ii) The Firms/ Companies/ Registered Contractors should have annual financial turnover of not less than (40% of the estimate cost) in any one year in construction works during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @10% per completed financial year (on compound basis) shall be given on the annual turnover of the preceding years. Bidder shall furnish complete audited annual financial year statements for last five years including audit report, balance sheets, profit & loss accounts statement all other schedules etc. in support of meeting the financial criteria as mentioned above.
  - (iii) If the bid has been invited in a common notice for different works or tender invited for different works in consecutive notice in a shorter time period, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.
  - In such cases, the order of opening of the bids shall be that in which they appear in the 'Invitation for Bids'. Fulfilment of One's bid capacity and other eligibility criteria in any one or more bids (in seriatim) will make him ineligible for subsequent bids.
- 11. The contractors those who are not signing agreement after repeated reminders may not be consider further works.
- 12. The firms/ companies/ registered contractors those have not completed more than three works under this division within the stipulated time will not eligible to participate the tender.
- 13. A contractor having even a single incomplete PWS scheme work at hand under RWS&S Circle, Bhubaneswar with more one year time over run from schedule date completion will be considered as Technically Disqualified. He has to give an undertaking that effect in his affidavit i.e. "I am not having even a single PWS Scheme work at my hand with more than one year time over run from the schedule date of completion under RWS&S Circle, Bhubaneswar as on the bid submission date".
- 14. The bid for the work shall remain valid for a period of 90 days from the date of receipt of the bid. If any bidder/ tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, Earnest Money Deposit (E.M.D) deposit at the time of submission of tender shall stand forfeited.
- 15. Engineering Contractors desirous for availing exemption of E.M.D/ISD, are required to submit affidavit along with their bids to the effect that, he/ she has not yet availed the facility for more than two works during the current financial year failing which his/her tender will not be considered. Further they have to produce original Contractor's Registration Certificate at the time of opening of tender for verification.
- 16. S.C/S.T contractors desirous for any preference/ concession/ exemption are advised to furnish affidavit and copy of relevant documents along with their tender documents.
