- 3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/modifications/addendum to DTCN if any.

- 4. a) The bidder should make payment through online receipt towards Tender Paper Cost. No off line receipt of Tender Paper Cost will be allowed in e-Procurement portal of Government of Odisha.
  - b) As per Government of Odisha FDOM No.8943 dated 18.03.2021, No.18281 dt.31.12.2021 & No.8484 dt.05.04.2022 of Works Department, Govt. of Odisha, the bidders are not required to submit 'Bid Security', but have to submit a 'Bid Security Declaration' in the Format appended herewith as 'Schedule-J' which should be submitted in the letter head of the bidder signed by the bidder himself or by the Power of Attorney Holder.

The original documents i.e., Affidavits, Undertakings & Certificates as per the Schedules and Annexure of DTCN that have been uploaded by the bidder in the etender website should be submitted for verification during evaluation. # 7. **Minimum Eligibility Criteria:**

i) Bidder shall fulfill following Eligible (Qualification) Criteria.

#### 7.1 **Technical Criteria:**

- i) Bidder shall be Manufacturer of Ductile Iron Pipes,
- ii) The manufacturer should have valid Bureau of Indian Standards (BIS) license for marking ISI mark on their product for at least 5 (Five) years from the last date of Bidding,
- iii) The manufacturer's Ductile Iron (D.I) pipes& fittings are in satisfactory performance in Indian Projects for at least three years from the Bid Date.
- iv) The Manufacturer should not be black listed by any Government/ Government undertaking for supply of DI pipes in India
- v) The Manufacturer should not have been black listed/ debarred/ disqualified with respect to Quality issues by any Government/ Government undertaking as a procuring entity, for supply of DI Pipes in India, in last 3 (three) years from the date of submission of tender.
- vi) The Manufacturer, in the last 3 financial years, has not applied for/ nor undergoing Corporate Debt Restructuring (CDR) / Strategic Debt Restructuring (SDR) nor facing recovery proceedings from Financial Institutions nor facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR)

### **Document required:**

- Copy of the valid BIS License of the product to be supplied.
- ❖ Document/Certificate in support of satisfactory performance of D.I pipes& fittings in Indian projects for at least three years shall be furnished duly certified by an officer not below the rank of Executive Engineer or appropriate authority.
- Self-Declaration Certificate by the Manufacturer in the form of Affidavit that "The Manufacturer has not been black listed by any Govt./Govt. undertaking for supply of DI pipes in India"

- ❖ Self-Declaration Certificate by the Manufacturer in the form of Affidavit that "The Manufacturer has not been black listed/ debarred/ disqualified with respect to Quality issues by any Government/ Government undertaking as a procuring entity, for supply of DI Pipes in India, in last 3 (three) years from the date of submission of tender"
- ❖ Self-Declaration Certificate by the Manufacturer in the form of Affidavit –declaring that "The Manufacturer, in the last 3 financial years, has not applied for/ nor undergoing Corporate Debt Restructuring (CDR) / Strategic Debt Restructuring (SDR) nor facing recovery proceedings from Financial Institutions nor facing Sickness and under consideration of Board for Industrial and Financial Reconstruction (BIFR)"

### 7.2. Financial Criteria:

Bidders should have annual financial turnover of not less than 40% of estimated cost in at least one year during last 5 (Five) preceding financial years. Inflation/Escalation @10% per financial year (on compound basis) shall be considered on the value of annual turnover of the proceeding years.

Bidder shall furnish audited annual financial year statements i.e. balance sheets, profit and loss accounts, corresponding schedules and auditors support as a part of published annual report in support of meeting the financial criteria as mentioned above.
