- Name of the Post : One Consultant—(**Group-A in Level 11 to 14**) under ORSP Rules,2017 .
- Qualification : Retired Administrative Officer/Establishment Officer having minimum 5 years experience of working in the Forestry and Accounts matter, preparation of schemes and its financial monitoring. Preference will be given to the applicant having experience in Compensatory Afforestation Programme.
- Age : The age of the applicant should not be less than 40 years and more than 64 years of age as on the date of Advertisement & he should be physically fit.
- Remuneration : The person who will be engaged as Consultant in Level 11 to 14 under ORSP Rules, 2017 will be paid remuneration of **Rs.35,000/-** (Rupees thirty five thousand) only per month and no other allowance like D.A., H.R.A., T.A., Medical reimbursement etc. will be admissible. Facilities like transport and residential accommodation will not be provided as per Govt. of Odisha, Finance Deptt. O.M. No.24533/F Dt.29.09.2022.
- Work assignment : One Consultant will be engaged in the State Authority, CAMPA Cell, O/o the PCCF & HoFF, Odisha to assist matters relating to PAC, Audit Para of AG (A&E), compliance to the paras of Departmental Monitoring Committee (DMC), C&AG Report, AG's POMs etc. and preparation of compliance to queries made by National Authority, assist in compilation of Annual Report and other assignment as and when required. The Establishment Officer/Section Officer of the CAMPA wing will assign the work to the consultants and the consultant will report the day to day work to the Establishment Officer/Section Officer of the wing.

Term and condition :

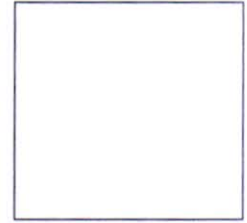
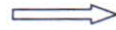
