The Executive Engineer, Rural Works Electrical Division, Bhubaneswar on behalf of Governor of Odisha invites percentage rate bids in double cover system through e-procurement for Electrical work for 2022-23 as per Annexure. The bid should be submitted on-line in the website www.tendersorissa.gov.in by from Valid Electrical Contractor Registered as H.T. under Electrical License Board Of Odisha, Govt. Of Odisha and contractors of equivalent grade class registered with Central government CPWD, IMES, or relevant class of other licensing authorities. The registered bidders of outside Odisha, can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work.

1	E.M.D. required	:	As per Works Deptt. Memorandum No. 5984 dt. 27.04.2021, the bidder must upload "Bid Security Declaration" in lieu of furnishing EMD at the time of submission of Bid as per format enclosed in DTCN. Exemption from EMD is permissible as per codal provisions of Govt. of Odisha.
2	Cost of tender paper	:	The bidder shall transfer online the cost of bid document for Rs. 10,000/- towards tender costing Rs. 166.78 lakhs towards cost of Bid through a process as mentioned under DTCN.
3	Additional Performance Security	:	The successful bidder who has quoted less bid price/rates than the estimated cost put tender shall have to furnish the exact amount of differential cost (mentioned below) as Additional Performance Security in shape of Term deposit Receipt pledged in favour of RW Elect.Divn. Bhubaneswar /Bank Guarantee in favour of RW Elect.Divn. Bhubaneswar for any Nationalised /Schedule Bank in India counter guaranteed by its local Branch at Bhubaneswar within seven days of issue of letter of acceptance (LOA) by this office (by e-mail) to the successful bidder otherwise bid of the successful bidder shall be cancelled and the E.M.D./ Bid Security shall be forfeited..

8. Tender must accompanied with format of ' Bid security declaration from bidders in lieu of EMD (on bidders letter head) This is as per the O. M no 8943 dt. 18.3.2021 of Finance dept. is enclosed in the DTCN . Tenders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to transfer online 2% of the amount put to tender as Bid Security. Exemption from EMD is permissible as per codal provisions of Govt. of Odisha
9. The Additional performance security of the amount of difference shall be imposed only successful bidder in shape of Term deposit Receipt pledged in favour of RW Elect. Divn. Bhubaneswar /Bank Guarantee in favour of RW Elect. Divn. Bhubaneswar for any Nationalised /Schedule Bank in India counter guaranteed by its local Branch at Bhubaneswar , which is required to be provided before drawl of agreement or else the bid of the successful bidder would be cancelled & the security deposit would be forfeited alongwith other action as per terms of DTCN.
10. Bid documents consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings & the schedule of quantities of the various classes of work is available in website www.tendersorissa.gov.in
11. The rates quoted by the Contractor shall be exclusive of G.S.T.The GST as applicable for the work contract shall be payable to contractor on each bill amount.
12. The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderor withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
13. A bidder shall not be permitted to bid for works in the R.W.Elect. Division, Bhubaneswar for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted in the rank of Asst. Engineer & above in any Engineering Deptt. or in the rank of Under Secretary & above in any Public Works Deptt. Under Govt. of Odisha.
14. The contractor has to upload an Affidavit individually for each work regarding correctness of all the document uploaded in the website.
15. If the rate quoted by the bidder is less than 14.99% of the tendered amount then such a bid shall be rejected & the tender shall be finalised basing on merits of rest bids. But, if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than estimated cost, the tender accepting authority will finalise the tender through a **transparent lottery system**, where all bidders/their authorised representatives, the concerned Executive Engineer and DAO will remain present.
16. **The single tender received in the 1st call shall be cancelled without opening of the bid.**
17. The bid of any contractor whose tender has been rescinded or who has abandoned any work within 5 years will be rejected without showing any reason thereof. This provision should form a part of the affidavit submitted as per Clause No.-12 above.
18. If the lowest Bidder fails to submit the original documents for verification within 5-days of opening of this tender, his bid security shall be forfeited and his portal registration shall be cancelled and his name shall also be informed to the registering authority for cancellation of his registration.
19. Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in / www.orissa.gov.in
20. Employer shall not accept any responsibility for failures or breakdowns of the electronic procurement system during the e-tendering process. In case of such system failure, malfunction, or breakdown during the bidding process, an e-mail will be sent to all registered bidders or a notice will be published on the Employer's e-procurement portal notifying the specific changes(if any) on the key dates of tender as appropriate.
21. Any other Corrigendum/Addendum/Clarification will be published on the e-procurement portal notifying the specific changes or modification if any.
22. In case, the date of opening of Technical Bid/Financial Bid falls on a Govt. declared holiday, then the same will be opened in the next official working day.
23. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.


