The *Superintending Engineer, RWS&S Division, Rairangpur* on behalf of Governor of Odisha invites bids from bidders of eligible class registered with the Odisha State Government and bidders of equivalent Grade / Class registered with Central Government / MES / Railways for the works detailed in the table below to be eventually drawn up in P1 contract with design and execution. The bidders may submit bids for any or all of the following Pipe Water Supply works.

Note: *The amount put to tender is exclusive of GST. The intending bidders should offer their rates which shall be exclusive of GST applicable as per norms. **GST applicable on works contract shall be paid over the bill amount at the time of payment of bill.***

2. Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State failing which the bid security shall be forfeited the said bid stands cancelled.
3. The Bid documents shall be downloaded from website: <https://tendersodisha.gov.in> from [Dt. **29.12.2022 at 10.00 hrs to Dt. 16.01.2023 up to 17.00 hrs**]. **The bid document can be downloaded from website, for submission of the bid in the prescribed format, by the intending bidder. The bid cost shall be non-refundable.**
4. Bids shall be received only "on-line" on or before [Dt. **16.01.2023 up to 17.00 hrs**]. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes/ modifications/ addendum to DTCN if any.
5. A pre bid meeting shall be held on [date:**12.01.2023. at 11.00 hrs**] at hours [O/O SE, RWSS DIVISION RAIRANGPUR] to clarify the issues and to answer question on any matter that may be raised at that stage as stated in Clause 9.2 of the bidding document i.e. 'Instruction to Bidders'
6. Bids must be accompanied with electronic receipt obtained through payment gateway of designated banks listed in Government e-procurement portal for bid security and cost of bid documents as specified for the work in the table along with bid documents during on line submission vide Office Memorandum No. 17254 dated 05.12.2017 of Works Department, Govt. Of Odisha.

7. Bids received on-line on due date and on time shall be opened **on 11:00 hrs dt. 17.01.2023** in the office of SE RWSS DIVISION RAIRANGPUR in the presence of the bidders or their authorised representations who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

8. Other details can be seen in the bidding documents (DTCN).
9. The authority reserves the right to cancel any or all bids without assigning any reason.
10. Bids from **consortium / Joint ventures** is not acceptable.
11. The system generated acknowledgement receipt along with original copies of all the documents that have been uploaded in the e-tender website by the bidder should be submitted to the SE RWSS DIVISION RAIRANGPUR for verification within a specified period after intimation to the bidders.
12. 3rd party Inspection of all component works will be conducted as per decision taken by Govt. In PR&DW deptt. for which AA cost is more than 1 (one) crore.
13. While evaluating tenders, provisions made in OPWD Code will be strictly followed. Also the Govt. Circulars issued from time to time will be followed strictly.
14. In case of Engineer Contractor not having availed EMD exemption in more than two works an undertaking to the effect that *"Being an Engineer Contractor, I have not availed EMD exemption in more than two works in this financial year of 2022-23"* has to be clearly mentioned in the Affidavit. The Engineer Contractor has to upload all the pages of licence including blank pages for verification of entries made in award if works with exemption of EMD.
15. The Bid must be accompanied with Bid Security Declaration (SCHEDULE-J) as per Finance Deptt. Govt. of Odisha Circular No. 8943 dt. 18.03.2021 & subsequent Works Deptt. Office Memorandum No. 5984 dt. 27.04.2021. No provisions regarding Bid Security should be kept in the Bid Documents and only provision for "Bid Security Declaration" should be kept for all participating venders.
16. All amendments, time extension, clarifications etc. Will be uploaded in the website only. Bidders should regularly visit the above website to keep themselves updated.
17. The Bidder is advised to visit the site and make him conversant about the site requirement before bidding.
