All the above shortlisted candidates are mandatorily required to attend the document verification process in their allotted district headquarters as per the schedule & venue given in their Intimation Letters. If any candidate fails to attend the document verification process, his candidature shall be rejected and he shall not be allowed to participate in the recruitment process any further.

The candidates may see the detail results by logging in the Commission's web portal with their user Id and password. The shortlisted candidates are advised to download Intimation Letters and appear before the District Level Board for verification of original documents by logging in the web portal of the Commission [www.osscc.gov.in](http://www.osscc.gov.in) with their User ID and Password. **No hardcopy of Intimation Letter will be sent to any candidate by post.**
