6. The bidder has to deposit the bid cost (as per Col.5) through payment Gate way of designated Bank as per office memorandum of Works Department , Govt. of Odisha No. 17254 dt. 5.12.2017.

7. Contractors will upload the bid security and authenticity of their uploaded documents in shape of Affidavit online along with their bid documents. The Authority will not be held responsible for any technical snag or network failure during online bidding.
8. **The Authority reserves the right to cancel any or all bids at any stage without assigning any reason thereof.**
9. The last date seeking clarification towards “e” Procurement portal using his/her DSC up to 17.00 Hrs of Dt. **20.01.2023.**
10. Any Corrigendum/ Addendum will be displayed in the above website only.
11. Scanned clear copies should be uploaded. Invisibile copies of Documents may be liable for rejection.
12. The amendments made vide Works Dept. Memorandum No. 12366 Dtd 08.11.13, No- 10224 Dt. 01.09.2015 and Lt. No:- 20415 Dt 14.09.2015 towards general instruction to the contractor except para 3.5.5 (v) Note II of OPWD code, Vol-I will be followed scrupulously regarding rate to be quoted etc.
13. As per O.M No 4559 dated 05.04.2021 of works Department, Government of Odisha The Additional Performance Security to be deposited as per following rate.

The Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender as above shall have to furnish the Additional performance Security (APS) in shape TDR/ Kissan Vikash Patra & Postal Office Saving Certificate issued by any nationalized/ Scheduled Bank located in India pledged in favour of the Superintending Engineer, M.I Division, Jashipur within 7 (Seven) days , otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder.

14. If more than one bid will be ^{1st} lowest the tender will be decided through a transparent lottery system in presence of the bidders or their authorized representative. In such case of lottery need to be conducted in accordance with the works department order no.12366 dtd 8.11.2013, the lottery date will be intimated subsequently in the tender web site.
15. The Contractors who have **more than three works pending** under this Division and who has not completed the work in time and contract has been closed or recommended for closer with penalty under this Division at the time of bidding are not eligible to participate in the present tender.
16. The estimated cost put to tender is exclusive of GST as applicable.
17. Affidavit and supporting documents towards claim of exemption of EMD, price preference etc should be uploaded along with the tender documents failing which such claim shall not be considered.
18. The intending bidders should visit the work site before tendering and should be prepared with required machineries for earth work and concrete work to complete the work by the scheduled period of completion.
19. The intending bidders are required to furnish their valid e-mail address and cell phone number so as to inform them anything relating to tender which is mandatory.
20. Time is the essence of the contract and extension of time may not be allowed. Penalty will be imposed as per Agreement condition if the work is not completed within the stipulated period or not in proportion to the work programme.

21. The tender/tenders, where all technical qualified bidders for each package have quoted same rate at par with schedule of rates will be cancelled without any transparent lottery system as per Letter no. 7787 dated 31.05.2021 of Govt. of Odisha Works Department.
22. The bidder should Execute a “**Bid Security Declaration**” in lieu of Bid Security with stipulation that if they withdraw or modify their bids during period of validity etc. they will be suspended from participating any tender under this Division for a period of one year vide the letter 8943 dated 18.03.2021 of Principal Secretary to Finance Department, Government of Odisha.
23. As per Para 12.4, Para 12 in Appendix IX (A of OPWD Code Voll-II as follows-“Resistration in the contractors data base Management System (CDMS) available at www.cdmsodisha.gov.in by all contractors is mandatory”
24. **The SC/ST contractors willing to avail 10% price preference should furnish the original affidavit during submission of bid.**
25. The Bids received on line shall be opened in the office of Superintending Engineer, M.I.Division, Jashipur on **21.01.2023.**
