The Executive Engineer, R.W Electrical Division, Sambalpur on behalf of Governor of Odisha invites **Percentage Rate bids** in **single cover system** in **online mode** for the works as detailed in the table given below. The electrical contractor must have valid license from ELBO, Bhubaneswar. The bidders may submit bids for the following works

6. The Bidders have to participate in online bidding only. Further details can be seen from the Web Site [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) only. Any Corrigendum / Addendum/cancellation of tender will be displayed in the website said only.

- 7) The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) from **11:00 Hours of 24 .01.2023 to 17:00 Hours of 02.02.2023**
- 8) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class III.**

- 9) Bids shall be received only "On-line" on or before **17:00 Hours of 02.02.2023.**
- 10) Bids received "on-line" shall be opened at **11:30 Hours on dtd.03.02.2023** in the office of the **Executive Engineer, R.W Electrical Division, Sambalpur, Odisha** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 11) The rates quoted by the Contractor shall be exclusive of G.S.T.
- 12) The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
- 13) A bidder shall not be permitted to bid for works in the R.W. Electrical. Division, Sambalpur for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted in the rank of Asst. Engineer & above in any Engineering Dept. or in the rank of Under Secretary & above in any Public Works Deptt. Under Govt. of Odisha.
- 14) The contractor has to upload an Affidavit individually for each work regarding correctness of all the document uploaded in the website.
- 15) If the rate quoted by the bidder is less than 15% of the tendered amount then such a bid shall be rejected & the tender shall be finalized basing on merits of rest bids. But, if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than estimated cost, the tender accepting authority will finalise the tender through a **transparent lottery system**, where all bidders/their authorised representatives, the concerned Executive Engineer and DAO will remain present.
- 16) It has been made mandatory vide Finance Dept. Office Memorandum No.8943 dtd.18.3.2021 for all the contractors including Engineer contractors to submit the "Bid Security Declaration" in lieu of Bid Security and the bidders are not allowed withdraw or modify his bid during his bid period of validity. The participating bidders must have to submit their Bid Security Declaration even the bidders of outside the state failing which the bids shall be summarily rejected. Further proceeding for blacklisting shall be initiated against the bidder.
- 17) No Additional Performance Security for the bid below 5% (b) Only the successful bidder have to submit his/her additional performance security amount @150% of (Difference between estimated cost put to tender and Bid amount) if the less percentage of bid is 10% or more upto 14.99% (c) APS will be 50% of (Difference between estimated cost put to tender and Bid Amount) if the bid is 5% less to below 10%. The bidder has to submit his / her APS in shape of T.D.R/NSC/KVP pledged in favour of the Executive Engineer , R.W Electrical Division ,Sambalpur within 7 days from issue of acceptance letter otherwise the bid shall be cancelled and action deemed proper will be initiated against the bidder . Further proceeding for black listing shall be initiated against the bidder.
- 18) The single tender received in the 1<sup>st</sup> call shall be cancelled without opening of the bid.
- 19) The bidder shall transfer online the cost of bid documents as shown in column-5 above through a process as mentioned in DTCN.
- 20) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
- 21) If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant codal practice will be taken against him/her.



- 22) Any tenderer desires to avail any facility as per certain circular /order of Govt. have to apply for same along with tender paper. Claim at the time of opening of tender or later will not be entertained.
- 23) Authority will not be held responsible for any technical problem/ failure of network, server during the schedule dates of online bidding.
- 24) Conditional tender will be summarily rejected. The Authority reserves the right to reject any or all bids without assigning any reason thereof.
