**CORRIGENDUM**

After discussion with the prospective bidders in the pre-bid meeting held on 06.01.2023 following provisions/clauses of the RFP No 15675 Dated 28-12-2022 of I & P.R. Department are modified as here under.

1. The proposal due date in (**bidder datasheet**), Sl.4 and the last date and time for submission of the proposal completed in all respects at Sl.4 of (**letter of invitation**) may be read as **30.01.2023 at 1 P.M.**
2. The date of opening of proposal at Sl.No.5 of (**bidder datasheet**) and the date and time for the opening of the technical bid in presence of the bidders or their authorized representative at the specified address at Sl.4 of(**letter of invitation**) may be read as **Dt. 31-01-2023 at 11.00 A.M.**
3. Point No. 3(3). (**Key Deliverables**). May be read as “The agency shall maintain the prescribed minimum standard black back flex of 260 GSM weight. “
4. Point No. 3(8). (**Key Deliverables**). May be read as “During the campaign period the agency shall submit a **fortnightly** report by E-Mail in the prescribed pro-forma on the hoarding to the client, concerned department and district administration. It should contain pictures with time and location stamped on it.”



5. Point No. 4 (6).(**Eligibility criteria**) May be read as “The bidders should have minimum turnover of Rs.1 Crore per annum in last three Financial Years. The bidder must submit an Annual turnover certificate of the last three Financial Years duly certified by CA (indicating membership no. of CA with seal) ending on **31.03.2022** with an audited balance sheet of the last three Financial Years.”
6. Point No. 11. (**Financial Bid & Financial Evaluation**) May be read as “The Financial Bid is to be submitted as per the prescribed Format at Section: 4 separately for each zone in a sealed cover. Least Cost Based Selection (LCBS) method will be followed during the overall selection process. The client will select the lowest evaluated price bid among all the qualified bids. For the purpose of evaluation, the total lowest evaluated cost (cost of Printing of **black back flex** + cost of Mounting of Hoardings + cost of Rental Charges of Display of Hoardings per month) shall be inclusive of all overhead expenses and applicable taxes for which the client makes payment to the agency. The successful bidder shall be selected taking into consideration of the lowest bid (L-1) in the most transparent manner. There will be separate selection of lowest evaluated cost for 4 categories such as permanent Hoarding, Temporary iron framed Hoarding, Temporary bamboo/baton framed Hoarding and Wall wrapping in each Zone. The Tender Publishing Authority can negotiate the rates with the L-1 bidder and finalize the rates accordingly. The authority is not bound to accept the L-1 rates. If the L-1 bidder fails to sign the agreement then negotiations with Firms other than the (L-1) lowest bidder i.e. L-2 bidder shall be held upon obtaining prior approval of the competent authority. The State has been divided into eight Zones. A bidder can participate in a maximum 6 (six) different zones.”
7. Point No. 13 (3).(**Documents required to be submitted**) May be read as “Annual Turnover Certificate of last three financial years duly certified by C.A. (indicating membership no. of C.A. with seal) ending on **31-03-2022** with an audited balance sheet of last three financial years.”

9. Another condition is added to the Point No. 3 (**Key Deliverables**). This may be read as Point No. 3(11) of (**Key Deliverables**).

As soon as Mobile app is provided by the Department for monitoring of the display of the Hoardings, all photographs have to be uploaded on the mobile app during the installation of flexes on the hoardings. This will be treated as proof of mounting and start date of the campaign will be decided based on this. Further all sites will have to be monitored regularly by the bidder and monitoring photos in a gap of 15 days have to be uploaded in the mobile app. Failure to upload photos uploaded in the mobile app will result in non-acceptance of bills. Deductions in the bills will be made accordingly. Kindly note that the uploading of photos in Mobile app is mandatory.
