The Bidder shall be manufacturer/ dealer/sub-dealer of the materials, having valid GST and PAN.

- The manufacturers should not be black listed/debarred/disqualified with respect to the quality issues 8. by any Govt./Govt. undertaking as a procuring entity, for supply of pump motor sets in India, in the last three years from the date of submission of the tender (Self-declaration certificate shall be submitted by the manufacturers in the form of affidavit). 10.
- Document required:
 - Copy of the valid BIS License of the product to be supplied.
 - * Document/Certificate in support of satisfactory performance of pump motors in Indian projects for at least three years shall be furnished duly certified by an officer not below the rank of Executive Engineer or appropriate authority.
