**ORDER FOR CANCELLATION OF TENDER**

WHEREAS, a Tender Call Notice No.D-199 was published in daily News Paper on 28.10.2022 for 2023-24 for procurement of principal food grains and other essential misc. articles of all Jails of Odisha, inviting application from the eligible Contractors/ Bidders with IT return having gross annual income of Rs.10 lakhs & above for Circle Jail, Rs.8 lakhs & above for District and Special Jails and Rs.6 lakhs for Sub-Jails along with bidders Turnover @ 10 times of IT Returns i.e Rs.1 Crore, Rs.80 lakh, Rs.60 lakh for Circle Jail, District & Special Jail and Sub-Jail respectively which is higher than the previous year.


AND WHEREAS, challenging the above criteria for eligibility and qualification, some small suppliers/ Bidders/ Firms who used to supply dietary and Misc. Articles have submitted their representations received through Janasunani portal for relaxation of IT Return having gross annual income / Annual Turnover to the extent of Rs.3 lakh, Rs.5 lakh & Rs.7 lakh at par with previous year i. e 2022-23.

AND WHEREAS, the Senior Superintendent and Superintendent of Jails were asked to furnish the comparative status of Tender for the year 2022-23 and 2023-24. It is noticed that more numbers of responsive bids were received during the previous year 2022-23 than the current Tender Call Notice for 2023-24.

AND THEREFORE, the Directorate in consideration of fundamental principles of public buying where every authority delegated with the Financial Powers of procuring goods in public interest shall have the responsibility to bring efficiency, economy, transparency in the matter relating to public procurement and for fair and equitable treatment of suppliers and to promote healthy competition & to secure best value for money, pleased to cancel the Tender Call Notice No.D-199 which was published in daily News Paper on 28.10.2022 for 2023-24.

This order is passed in compliance to the Order No. 01 dated 02.02.2023 passed by the Hon'ble High Court in WP (C) No. 2736 of 2023.

The last date of submission of application for registration of the approved supplier in Tender Call Notice No. 2314 dated 25.01.2023 published in daily Newspaper "The Samaj" & "The Times of India" on 31.01.2023 for procurement of dietary and misc articles for the year 2023-24 is hereby extended from 20.02.2023 to 06.03.2023. The sealed tenders quoting rates etc. are to be submitted directly to the concerned Superintendent of Jails on or before 5.00 PM of 25.03.2023 after registration. Sealed tenders will be opened at 3.00 PM on 26.03.2023 in consultation with the Chairman of the concerned Dist. Level/ Sub-Divisional level of Purchase Committee. All other terms and conditions published in the Tender Notice No. 2314 dated 25.01.2023 are remain unaltered.
