### **Invitation of online application for Combined Recruitment Examination-2023 for the district cadre posts of Junior Assistant and Panchayat Executive Officer**

The Advertisement No. IIE-07/2023-492(C)/OSSCC dated 24.02.2023 has been published inviting applications online for the Combined Recruitment Examination-2023 for 3099 number of posts of Junior Assistant (JA) and 2297 number of posts of Panchayat Executive Officer (PEO) in various district establishments under different departments of Government of Odisha . In the meantime, Government in Revenue & Disaster Management Department have further sanctioned 1466 number of posts of Junior Assistant under various district establishments. Further, there are some changes in category of posts of Junior Assistant in the district of Cuttack & Mayurbhanj which have been corrected. Now the final total number of vacancies of Junior Assistant is 4565 (3099+1466) which is published herewith for information of all concerned. Similarly, there are some changes in the category of posts advertised for the post of PEO in the district of Jajpur which is corrected and published herewith. Accordingly the posts advertised earlier have been revised and finally published herewith as under.

1. The vacancies for the post of Junior Assistant is 4565 as at Annexure-I.  
The department-wise/ district-wise/ category-wise breakup for the post of Junior Assistant is published at Annexure-I.A for better appreciation.
2. The total number of vacancies for the post of Panchayat Executive Officer remains the same as 2297 and published herewith at Annexure-II.
3. All other terms and conditions of the detailed advertisement available in the web portal of the Commission [www.osscc.gov.in](http://www.osscc.gov.in) remains unaltered.
4. The last date of Submission of Online Application remains the same i.e., **27.03.2023**. The applicants are advised to submit online applications well in advance without waiting for the last date in order to avoid the last hour rush.

The candidates have to login, furnish the details of the required documents, then proceed to fill up and submit the online application as per the guidance of the system.
