- All the candidates who have already registered/re-registered for CRE- 2023 by today i.e. 22nd March are advised not to try for Filing Application online upto **27th March 2023** as this feature is disabled. They are advised to wait till 28th March to re-initiate the process of filing application.
- From **28th March to 7th April 2023** FILLING OF APPLICATION only is allowed for the candidates who have Registered/Re-registered by 27th March and in the waiting. No fresh registration/re-registration will be allowed during this period.
