- 12) The bid for the work shall remain open for acceptance for a period of Thirty days days from the Last date of receipt of bids. But, if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system, where all bidders/their authorised representatives, the concerned Executive Engineer and DAO will remain present.
