The **General Manager, WATCO, Division,Puri, Odisha** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Single Bid system from **"Manufacturer "** registered with the Odisha State Government and Reputed Engineering Firms registered as **"Manufacturer "** to be eventually drawn up in the standard **P1 Contract Form**. The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.
