Personnel means professional and support staff provided by the Agency to perform Services to execute the assignment and any part thereof

3. Period of Contract

a. The assignment is for **six months**. If the selected agency fails to perform the functions as agreed upon in the contract to be signed with Office of PCCF & Head of Forest Force, Odisha or commit breach of any of the terms and conditions, provisions or stipulations of the contract, the office shall take appropriate action including termination of the contract with the agency.

5. Bid Processing Fee:

The bidder must furnish, as part of technical proposal, the required bid processing fee amounting to Rs. 5000/- (Rupees Five thousand Only) in shape of Demand draft / Banker's Cheque from any scheduled commercial bank in favour of "DCF, Headquarters", payable at Bhubaneswar. The bids received without bid processing fee will be rejected.

6. Earnest Money Deposit (EMD):

The bidder must submit, as part of the technical proposal, an Earnest Money Deposit (EMD) amounting to Rs. 1,00,000/- (Rupees One lakh Only) in shape of Demand draft / Banker's Cheque from any scheduled commercial bank in favour of "DCF, Headquarters" payable at Bhubaneswar. The bid not accompanying EMD is liable to be rejected. The EMD will not carry any interest. The EMD of unsuccessful bidders shall be refunded after finalization of selection process and award of contract. The EMD of the successful bidder will be released only after furnishing of the required Performance Bank Guarantee (PBG) and signing of the contract. The EMD will be forfeited on account of the following reasons:

- Bidder withdraws its proposal during the bid validity period as specified in RFP.
- Bidder has submitted false information in support of its qualification.
- Any other circumstance which holds the interest of the Client during the overall selection process.

7. Validity of the Proposal:

Proposals shall remain valid for a period of 180 (One Hundred Eighty Days) from the date of opening of the technical proposal. The Client reserves the rights to reject a proposal valid for a shorter period as non-responsive and will make the best efforts to finalize the selection process and award of the contract within the bid validity period.

9. Submission of Proposal:

Bidder must submit their proposals by Registered Post/ Speed Post/ Courier/By hand only to the specified address on or before the last date and time for submission of proposals as mentioned in Bidder Data Sheet. The Client will not be responsible for postal delay/ any consequence in receiving of the proposal. The proposal must have to be submitted in two parts Technical project & Financial project. Each part should be separately bound with no loose sheets. Each page of the two parts should be page numbered and in conformation to the eligibility qualifications and clearly indicated using an index page. . The duly filled-in financial proposal submission forms should contain the detailed price offer for the proposed assignment and have to be furnished as per the prescribed format only along with soft copy in pdf form in soft copy as part of financial proposal.

Bidders have to prepare a presentation as a part of the technical proposal (2nd stage). The objective of the presentation is to enable the Client to evaluate the bidders about their understanding and preparedness for the proposed assignment. Representatives with proper authorization letter from the participating bidder will be allowed to attend and deliver presentation in the technical presentation meeting.

The bidder whose technical proposal secures a score above minimum qualifying mark of <u>70</u> in the technical evaluation stage will be qualified for opening of the financial proposal. The financial proposals of the technically qualified bidders will be opened on the date and time mentioned in the Bidder's Data Sheet.

• **Financial Evaluation (Stage):** The financial proposals of the technically qualified bidders only shall be opened at this stage in the presence of the bidder's representative who wishes to attend the meeting with proper authorization letter. The name of the bidder along with the quoted financial price will be announced during the meeting.

12. Evaluation Process:

Combined Quality and Cost Based Selection (CQCBS) method will be followed during the overall selection process. Based on the evaluation of technical proposal, the technically qualified bidders shall be ranked highest to lowest Technical Score (ST) in accordance to the marks obtained during the technical evaluation stage. There shall be 60% weight-age to technical score and 40% weight age to financial score.

The individual bidder's financial score (SF) will be evaluated as per the formula given below:

13. <u>Taxes:</u>

Income Tax and GST (TDS) will be deducted from the contract value as per the prevailing statute.

14. Performance Bank Guarantee: (PBG)

Within 15 days of notifying the acceptance of proposal for the award of contract, the qualified bidder shall have to furnish a Performance Bank Guarantee amounting to 10% of the contract value from a scheduled commercial bank situated in Bhubaneswar in favour of "......", as per the format at Annexure-II, for a period of three months beyond the entire contract period (i.e. PBG must be valid from the date of effectiveness of the contract to a period of 3 months beyond the contract period) as its commitment to perform services under the contract. Failure to comply with the requirements shall constitute sufficient grounds for the forfeiture of the PBG. The PBG shall be released immediately after three months of expiry of contract provided there is no breach of contract on the part of the qualified bidder. No interest shall be paid on the PBG.

15. Contract Negotiation:

Contract Negotiation will be held at a date, time and address as intimated to the successful bidder. The bidder will, as a pre-requisite for attendance at the negotiations, confirm availability of all the proposed staff for the assignment. Representative conducting negotiations on behalf of the bidder must have written authority to negotiate and conclude a contract. Negotiation will be performed covering technical and financial aspects, if any and availability of proposed professionals etc.

16. Award of Contract:

After completion of the contract negotiation stage, the Client will notify the successful bidder in writing by issuing an offer letter for signing the contract and promptly notify all other bidders about the result of the selection process. The successful bidders will be asked to sign the contract after fulfilling all formalities within 15 days of issuance of the offer letter. After signing of the contract, no variation or modification of the terms of the contract shall be made except by written amendment signed by both the parties. Sub-contracting / outsourcing of any form shall not be allowed for any activities under the scope of the work as mentioned in this RFP.

17. Conflict of Interest:

Conflict of interest exists in the event of: (i) conflicting assignments, including implementing, providing consultation, monitoring and evaluation/environmental assessment of the same project by the eligible bidder; (ii) Consultants, agencies or institutions (individuals or organizations) who have a business or family relation with the Client directly or indirectly; and (iii) practices prohibited under the anti-corruption policy of the Government of India and Government of Odisha. The bidders are to be careful so as not to give rise to a situation where there will be any conflict of interest with the Client as this would amount to their disqualification and breach of contract.

18. Disclosure:

- a. Bidders have an obligation to disclose any actual or potential conflict of interest. Failure to do so may lead to disqualification of the bidder or termination of its contract.
- b. Bidders must disclose if they are or have been the subject of any proceedings (such as blacklisting) or other arrangements relating to bankruptcy, insolvency or the financial standing of the Bidder, including but not limited to appointment of any

- officer such as a receiver in relation to the Bidder's personal or business matters or an arrangement with creditors, or of any other similar proceedings.
- c. Bidders must disclose if they have been convicted of, or are the subject of any proceedings relating to:
 - a criminal offence or other serious offence punishable under the law of the land, or where they have been found by any regulator or professional body to have committed professional misconduct;
 - corruption including the offer or receipt of an inducement of any kind in relation to obtaining any contract;
 - Failure to fulfill any obligations in any jurisdiction relating to the payment of taxes or social security contributions.

19. Anti-Corruption Measure:

- a. Any effort by Bidder(s) to influence the Client in the evaluation and ranking of financial proposals, and recommendation for award of contract, will result in the rejection of the proposal.
- b. A recommendation for award of Contract shall be rejected if it is determined that the recommended bidder has directly, or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the contract in question. In such cases, the Client shall blacklist the bidder either indefinitely or for a stated period of time, disqualifying it from participating in any related bidding process.

20. Language of Proposals:

The proposal and all related correspondence exchanged between the bidder and the Client shall be written in the **English** language. Supporting documents and printed literature that are part of the proposal may be in another language provided they are accompanied by an accurate translation of the relevant passages in English with self-certification for accuracy, in which case, for the purposes of interpretation of the Proposal, the translated version shall govern.

21. Cost of Bidding:

The Bidder shall bear all costs associated with the preparation and submission of its proposal. The Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process. Bidder/s are not allowed to submit more than one proposal under the selection process. Alternate bids are also not allowed.

22. Legal Jurisdiction:

All legal disputes are subject to the jurisdiction of the Orissa High Court, Cuttack.

23. Governing Law and Penalty Clause:

The schedule given for delivery is to be strictly adhered to in view of the strict time schedule. Any unjustified and unacceptable delay in delivery shall render the Agency liable for liquidated damages and thereafter the Client holds the option for cancellation of the contract for pending activities and complete the same from any other agency at the cost of the agency. The rights and obligations of the Client and the Agency under this contract will be governed by the prevailing laws. Failure on Agency's part to furnish the deliverables as per the agreed timeline will enforce a penalty @ 1% per week subject to maximum of 10% of the total contract value. In case delay in the delivery of services is found not attributed to the Agency, the penalty may be waived.

24. Confidentiality:

Information relating to evaluation of Proposals and recommendations concerning awards shall not be disclosed to the bidders who submitted the proposals or to other persons not officially concerned with the process, until the publication of the award of contract. The undue use by any bidder of confidential information related to the process may result in rejection of its proposal and may be subject to the provisions of the Client's antifraud and corruption policy. During the execution of the assignment except with prior written consent of the Client, the bidder or its personnel shall not at any time communicate to any person or entity any confidential information acquired in the course of the contract.

25. Amendment of the RFP Document:

At any time before submission of proposals, the Client may amend the RFP by issuing an addendum through the website http://odishaforest.in, www.ofsds.in. Any such addendum will be binding on all the bidders. To give bidders reasonable time in which to take an addendum into account in preparing their proposals, the Client may, at its discretion, extend the deadline for the submission of the proposals.

26. Client's right to accept any proposal, and to reject any or all proposal/s

The Client reserves the right to accept or reject any proposal, and to annul or amend the bidding / selection / evaluation process and reject all proposals at any time prior to award of contract award, without assigning any reason thereof and thereby incurring any liability to the bidders.

27. Copyright, Patents and Other Proprietary Rights:

Forest and Environment Department, Government of Odisha shall be entitled to all intellectual property and other proprietary rights including but not limited to patents, copyrights and trademarks, with regard to documents and other materials which bear a direct relation to or are prepared or collected in consequence or in the course of the execution of this contract. At the Client's request, the Agency shall take all necessary steps to submit them to the Client in compliance with the requirements of the contract.

28. Replacement of Personnel:

The professionals to be deployed under this contract must be dedicated in nature. However, the Client reserves the right to request the Agency to replace the assigned personnel if they are not performing to a level of satisfaction. If, for any reason beyond the reasonable control of the Agency, such as retirement, death, medical incapacity, among others, it becomes necessary to replace any of the personnel, the Agency shall forthwith provide as a replacement a person of equivalent or better qualifications. After written notification, the Agency will provide CV of appropriate candidates within Seven (7) days for review and approval. The Agency must replace the personnel within seven (7) working days from the date of approval of replacement. If one or more key personnel become unavailable / leave the project for any reason midway under the contract, the Agency must notify the Client at least fourteen (14) days in advance, and obtain the approval prior to making any substitution. In notifying the Client, the Agency shall provide an explanation of circumstances necessitating the proposed replacement and submit justification and qualification of replacement personnel in sufficient detail to permit evaluation of the impact on the engagement. Acceptance of a replacement person by the Client shall not relieve the Agency from responsibility for failure to meet the requirements of the contract. Change in the professionals beyond the allowable limit of the contract leads to implication of liquidated damage of 10% of the contract value.

29. Force Majeure:

For purpose of this clause, "Force Majeure" means an event beyond the control of the Agency and not involving the Agency's fault or negligence and not foreseeable. Such events may include, but are not restricted, wars or revolutions, fires, floods, riots, civil commotion, earthquake, epidemics or other natural disasters and restriction imposed by the Government or other bodies, which are beyond the control of the Agency, which prevents or delays the execution of the order by the Agency If a Force Majeure situation arises, the Agency shall promptly notify Client in writing of such condition, the cause thereof and the change that is necessitated due to the condition. Until and unless otherwise directed by the Client in writing, the Agency shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The Agency shall advise Client in writing, the beginning and the end of the above causes of delay, within seven days of the occurrence and cessation of the Force Majeure condition. In the event of a delay lasting for more than one month, if arising out of causes of Force Majeure, Client reserves the right to cancel the contract without any obligation to compensate the Agency in any manner for what so ever reason.

30. Arbitration:

The Client and the Agency shall make every effort to resolve amicably, by direct negotiation, any disagreement or dispute arising between them under or arising from or in connection with the contract. Disputes not so resolved amicably within 30 days of receipt of notice of such as a dispute shall be resolved by a sole arbitrator nominated by the Office of PCCF & HoFF, Odisha. The arbitration proceedings shall be governed in all respects by the provision of the Indian Arbitration and Conciliation Act, 1996 and the rules there under and any statutory modification or re-enactment, thereof. The arbitration proceeding shall be held in Bhubaneswar.

31. Disqualification of Proposal:

The proposal is liable to be disqualified in the following cases as listed below:

- Proposal submitted without Bid Processing fee and EMD as applicable
- Proposal not submitted in accordance with the procedure and formats as prescribed in the RFP
- During validity of the proposal, or its extended period, if any, the bidder increases his quoted prices
- Proposal is received in incomplete form
- Proposal is received after due date and time for submission of bid
- Proposal is not accompanied by all the requisite documents/information
- A commercial bid submitted with assumptions or conditions
- Bids with any conditional technical and financial offer
- If the bidder provides any assumptions in the financial proposal or qualifies the commercial proposal with its own conditions, such proposals will be rejected even if the commercial value of such proposals is the lowest/ best value
- Proposal is not properly sealed or signed
- Proposal is not conforming to the requirement of the scope of the work
- Bidder tries to influence the proposal in evaluation process by unlawful/corrupt/fraudulent means at any point of time during the bid process
- Bidders or any person acting on its behalf indulges in corrupt and fraudulent practices
- Any other condition / situation which holds the paramount interest of the client during the overall selection process.

for

Formulation of two Monitoring & Evaluation Reports of activities under two CSSs - GIM & NAP Scheme implemented in Odisha

1. Current Status of SFDA Odisha and Implementation of GIM and NAP scheme:

- The State Forest Development Agency, Odisha was constituted on 17.06.2010 under the Societies Registration Act, 1860 with PCCF, Odisha as the Chairperson and Addl. PCCF (PP&A) as the Member Secretary and Chief Executive. The Chairpersons and Member-Secretaries of all 46 FDAs of the State are members of SFDA, Odisha.
- Now the operational structure for implementation of both the schemes has been revised in our State from 3 levels to 4 levels by adding Range Level in between FDA and VSS level.
- Fund Flow Mechanism: The schemes have been restructured as Centrally Sponsored State Plan Scheme (CSS) with a funding sharing pattern of 60:40 between Centre and State with effect from the financial year 2015-16 onwards.

2. Brief Background of the scheme:

A. Green India Mission (GIM)

- The National Mission for a Green India (GIM) was announced as one of the eight missions under the National Action Plan on Climate Change (NAPCC) and is being implemented with an aim at protecting, restoring and enhancing India's forest cover and responding to Climate Change.
- At national level, the Mission have an all inclusive Governing council, Chaired by the Minister, Environment and Forests to provide for overall guidance and synergy of action with the Mission Director as Member Secretary. It has a National Executive Council chaired by the Secretary (E&F) for having overall responsibility of the Mission and a Mission Directorate at the National level with the Mission Director as its CEO with overall accountability for the Mission deliverables.
- State Forest Development Agency, as autonomous society, facilitates the Mission implementation within the state.
- The overall objective of the National Mission for Green India (GIM) scheme is to increase forest/tree cover and improve the quality of forest /non-forest lands for enhancement of carbon sequestration along with provisioning benefits like fuel, fodder, timber & non-timber forest produces and increase the forest-based livelihood income level of forest fringe households.

• The Components/Interventions under the GIM scheme:

Plantation activities under prescribed submissions: Submission-1Aided Natural Regeneration, Artificial Regeneration, Urban Plantation, Avenue Plantation, Agro forestry & Social forestry and Promoting alternative energy for taking up afforestation activities.

Support activities: Livelihood improvement activities, strengthening local-level institutions, Monitoring Evaluation, Publicity/outreach activities, Research, Strengthening FDs, Mission organization, operation, maintenance, contingencies and overheads.

- Monitoring and Evaluation (M&E) is an important component under the GIM. The four level Monitoring and Evaluation (M&E) process i.e.
- **Level 1:** On –ground self-monitoring of the region by the local community, implementing organization and the Forest Department;
- Level 2: Field review by an external agency of randomly selected sites for Mission financed activities;
- **Level 3:** Remote-sensing-based forest cover monitoring by the Forest Survey of India and **Level 4:** A intensive monitoring of a few pilot areas to assess the impact and efficacy of different old and new practices, in tandem by the implementing agency, the Forest Department, and a support organization.
 - ✓ At present, field review by an external agency of randomly selected sites needs to be done for Mission financed activities.
 - ✓ An indicative Mission Performance Monitoring Framework (PMF) is presented in the matrix at Annexure-I as per Implementation Guidelines of GIM. The indicators for monitoring shown at Annexure-I are indicative; the State/implementing partners may evolve other indictors to monitor the progress, towards achieving of outcomes/results. The PMF has been developed synthesizing the outputs and outcomes stated in the mission document.

• Implementation Status of the GIM scheme in Odisha

- ✓ During the financial year 2011-12, National Afforestation & Eco-Development Board sanctioned the Grants-in Aid to SFDA Odisha for taking up preparatory activities under the Green India Mission Scheme.
- ✓ The scheme is implemented by <u>a four-tier institutional set-up</u>, namely State Forest Development Agency (SFDA) at the State level, Forest Development Agencies (FDAs) at the forest division level and range level involving Joint Forest Management Committees (VSSs/ EDCs) at the village level for carrying out plantation and ancillary activities.
- ✓ The scheme has been restructured as Centrally Sponsored State Plan Scheme (RCSS) with a funding sharing pattern of 60:40 between Centre and State with effect from the financial year 2015-16 onwards.
- (i) Under the approved project for five years (1st Project from 2015-16 to 2019-20) the scheme has been implemented in 5 identified landscapes in five divisions covering 50 VSSs in the state. As per this approved work programme, afforestation over a total area of 2198 ha (including distribution of seedlings for planting in farm land over 125 ha) has been achieved along with promoting alternative fuel energy to 2500 households in five identified landscapes.
- (ii) The 2nd project (2018-19 to 2022-23) was approved during 2018-19 under which 5537 ha area (including distribution of seedlings for planting in farm land over 950

- ha) have been afforested with promoting alterative energy devices to 1200 households in the previous selected five landscapes covering 69 VSSs (including VSSs covered under previous projects). The maintenance of such plantations is being carried out in subsequent years.
- (iii) The third project (2019-20 to 2023-24) which has been started during 2019-20, plantations over 4558.75 hectare, 1473.09 hectare and 537 hectare during 2020-21, 2021-22 and 2022-23 respectively have been achieved under different components and alternate fuel energy devices have been distributed to 2600 households in the selected landscapes covering 129 VSSs of fifteen divisions of the state.
- (iv) Similarly plantations over 2066 hectares have been achieved during 2022-23 under the 4th project (2021-22 to 2025-26).
- (v) 2030 ha of area will be afforested during 2023-24 under the project of fifth are (2022-23 to 2026-27)

B. Brief Background of the National Afforestation Programme:

The National Afforestation Programme (NAP) is operated by the National Afforestation and Eco-Development Board (NAEB), Ministry of Environment and Forests as a Centrally Sponsored Scheme. The objective of the scheme is to increase and/or improve Forest and Tree Cover for rehabilitation of degraded forests and other areas in participatory forest management processes for sustainable development and management of forest resources focusing on improvement in livelihoods of the forest-fringe communities, especially the poor.

• The components under the scheme are as follows:

Planting / Regeneration:

Aided Natural Regeneration (200 plants/ha), Artificial Regeneration (1100 plants/ ha), Pasture Development / Silvipasture (400 plants/ha), Bamboo Plantation (625 plants/ha), Planting of canes (625 plants/ha), Mixed Plantations of trees having MFP and medicinal value (1100 plants/ha) and Regeneration of perennial herbs and shrubs of medicinal value (2000 plants/ha).

Other components:

1. Strengthening of JFM: Constitution of JFMC (per JFMC) and Micro-planning (per JFMC), 2. Awareness Generation, 3. Micro-planning, 4. Fencing, 5. Soil & Moisture Conservation, 1. Entry Point activities, 7. Training & Capacity Building, 8. Value Addition and Marketing of Forest Produce, 9. Concomitant Monitoring & Evaluation, 10. Overheads, 11. Treatment of Problem Lands and 12. Use of Improved Technology.

• Monitoring and Evaluation Process for NAP scheme:

As per Para 9.2. of Revised Operational Guidelines 2009 of NAEB, each FDA project should be evaluated twice during the project cycle. The first, Concurrent Evaluation should be done in the 24-36 months of project operation for assessment of the degree of peoples' participation in the functioning of VSSs, in particular during micro-planning and implementation of initial project activities. The second evaluation i.e. Final Evaluation of the project, should be done after 3 years of the last tranche of tree planting in the project (after completion of the project) to focus on the quality of peoples' participation, success of regeneration, in terms of expansion and improvement in vegetation, and poverty impacts of the project.

As per guide lines of NAEB, the Concurrent/Final Evaluation is undertaken for assessment of the degree of peoples' participation in the functioning of JFMCs, in particular during microplanning and implementation of initial project activities and the final Evaluation focuses on the quality of peoples' participation, success of regeneration, in terms of expansion and improvement in vegetation, and poverty impacts of the project.

Evaluation of NAP projects by SFDA, Odisha:

As per guidelines of National Afforestation and Eco-development Board (NAEB), SFDA Odisha has formulated FDA wise 6 Consolidated Concurrent Evaluation Reports and 6 Final Evaluation Reports under NAP scheme up to the project period of 2014-15 to 2018-19, by engaging a third Party and transmitted the same to the National Afforestation & Eco-development Board, Ministry of Environment & Forests & Climate Change, Govt. of India during 2013-14, 2016-17 and 2018-19.

✓ At present, field evaluation by an external agency of randomly selected sites needs to be done for the NAP activities undertaken during the project period from 2015-16 to 2019-20, 2016-17 to 2020-21, 2017-18 to 2021-22, 2018-19 to 2022-23, 2019-20 to 2023-24.

• Implementation Status of the NAP scheme in Odisha

- ✓ The scheme is implemented by <u>a four-tier institutional set-up</u>, namely State Forest Development Agency (SFDA) at the State level, Forest Development Agencies (FDAs) at the forest division level and range level involving Joint Forest Management Committees (VSSs/EDCs) at the village level for carrying out plantation and ancillary activities.
- ✓ Fund flow mechanism: The scheme is being implemented on 60:40 of funding share between centre and state since 2015-16. During the financial year 2021-22 the scheme was merged and subsumed under the National Mission of Green India Scheme (GIM).
 - (i) Under the approved project for five years (2015-16 to 2019-20) during 2015-16, the scheme has been implemented in JFM areas of 23 FDAs in the state. As per this approved work programme, afforestation over a total area of 1975 ha has been achieved along with other works.
 - (ii) No project has been sanctioned during 2016-17 Financial year.
 - (iii) During 2017-18, the next project (2017-18 to 2021-22) was sanctioned for covering the JFM areas of 28 FDAs in the state. As per this approved work programme, afforestation over a total area of 4565 ha has been achieved along with other works.
 - (iv) The project (2018-19 to 2022-23) was approved during 2018-19 under which 3188 ha area have been afforested in the JFM area of 35 FDA divisions.
 - (v) The project of five years (2019-20 to 2023-24) was implemented involving JFMCs to afforest in their areas of 35 FDAs of the state. As per this approved work programme, afforestation over a total area of 6335 ha has been achieved along with other works.

3. Scope of the present evaluation:

The geographical scope of the present assignment extended to the both GIM/ NAP implementing divisions of Odisha. The present study will cover the activities (both plantation and support activities) undertaken in several JFMCs under different FDA divisions situated in 30 districts of the state. Out of the total existing 46 FDA divisions, 15 FDAs (namely

Berhampur/ Dhenkanal/Ghumsur South/Kalahandi North/Kalahandi South/ Sundargarh/ Bonai/ Angul/ Koraput/ Nabarangpur/ Rairangpur/ Bolangir/ Balliguda/Nayagarh & Bargarh) have implemented both the schemes .The present study will make an effort for reviewing the financed GIM & NAP activities undertaken in different JFMCs (VSSs) of respective divisions covered under different project periods which include:
