#### I. INTRODUCTION:

The Directorate of State Institute of Health and Family Welfare, Odisha is conducting various kinds of training programmes/workshops/meetings etc. for the medics and para-medics at the S.I.H & F.W, Odisha. In order to empanel credible Firm/Agency/Supplier to supply food items during various training programmes / workshop conducted under this Directorate, invitation for EoI is being floated by the Director, S.I.H & F.W, Odisha.

#### II. SCOPE OF WORK

- 1. The empanelled agency/firm/supplier have to provide and serve required breakfast, Tea/Coffee, Snacks & working lunch etc. to the participants/ Resource persons of the training programme/workshop/meetings etc., to be conducted under the Directorate of S.I.H & F.W, Odisha on the basis of work order issued to them as per requirement.
- 2. The price should not in any case exceed to Rs. 250/- (Rupees Two hundred Fifty only) including all taxes/charges i.e per person/participants included with breakfast, two water bottles (½ litres each) Tea/Coffee, Snacks & working lunch.
- 3. The selected bidder will serve the food items to the participants in the dining area, where the training programmes etc. will be conducted.
- 4. The batch size may increase or decrease subject to reporting of the participants & resource persons ( average 30 & maximum 50 participants per batch) & the payments shall be made as per actuals.
- 5. Payment shall me made only after completion of work & submission of bills/vouchers to the concerned authority. The Bills and vouchers shall be verified and certified by the wing officer i.e Joint Director Training, SIH&FW(O) to process payment.

#### III. ELLIGIBILITY AND QUALIFICATION CRITERIA

- 1. The Agency/Firm/Supplier intending to participate in the EoI should be a registered Firm/Agency/Supplier.
  - 2. The Agency/Firm/Supplier should have valid GST registration.
- 3. The Agency/Firm/Supplier should have minimum 3 years of experience in supply of food for the training programme of Govt. Deptt./PSU
  - 4. Valid food license issued by the competent authority up to March, 2024.
  - 5. The Agency/Firm/Supplier should have own office in Bhubaneswar.
- 6. The Agency/Firm/Supplier should have Average Annual turnover not less than 10,00,000/- for last three financial years, ending 31st March'2023.
- 7. The Agency/Firm/Supplier should not have been debarred/blacklisted by any Govt. Deptt. /PSU/ Cooperative Society for corrupt and fraudulent practices and shall have to submit a declaration to this effect. Agency who have history (if any) of unsatisfactory transaction with SIHFW in past are also not eligible to participate

#### IV. TERMS & CONDITIONS:

- 1. The EoI should be submitted as per scope and terms & conditions of the work as mentioned in EoI document.
- 2. The bidder should fulfil the eligibility criteria as mentioned in clause 1 to 7 of the eligibility criteria condition as above.
- 3. Each bidder shall submit only one proposal for the job, in response to this EoI. Any bidder who submits more than one EoI will be disqualified.
- 4. Bidders are required to deposit Rs. 1000/- (Rupees One Thousand) only (non-refundable) towards EoI application cost along with EoI in shape of DD favouring "Director SIH & FW, Odisha" payable at Bhubaneswar.
- 5. EoI must be accompanied by empaneled security amount of Rs. 30,000/- (Rupees Thirty Thousand) only in the form of FD/TDR pledged to the Director, SIH & FW, Odisha and shall be valid for 1 year beyond the EoI submission last date. Empanelment security of non-qualified bidder will be returned within 1 month from the date of finalization of empaneled bidder.
  - 6. EoI should valid for a period of 1 year w.e.f the date of agreement.
- 7. The Agency/Firm/Supplier would be empaneled in accordance with their eligibility criteria and Technical capabilities criteria of EoI document. Thereafter, as per need of the training/workshop/meeting of Directorate of SIH & FW, Odisha work order shall be issued.
- 8. The empaneled agency/firm/supplier will have to supply food items as per scope of work mentioned in the EoI document.
- 9. The selected agency/firm/supplier is required to provide and serve quality & tasty food. If the bidder failed to supply quality food & beverage at stipulated time then the Director is empowered to deduct the bill of that particular training date of the firm. The authorized Officers/officials of SIHFW(O) may verify the quality, quantity and hygiene of the food items at any time.
- 10. The preparation and cooking of food items are not allowed inside the premises. The same shall be arranged by the service provider at their own, only cooked food are allowed by the service provider to serve participants.
- 11. No bidder shall be allowed at any time on any ground whatsoever to claim revision of or modification in the rate.
- 12. If the successful bidder failed to execute the work within the stipulated period, then the security money amount will be forfeited.
- 13. The Director, SIH & FW, Odisha reserves the rights to accept or reject any bids, and to annul the bidding process and reject all the bids at any time prior to contract award without thereby incurring any liabilities to the affected bidder/bidders.
- 14. Before the deadline for submission of EoI, the Director, SIH & FW, Odisha may modify the EoI document by issuing in the Directorate official website "www.sihfwodisha.nic.in". The bidder are requested to visit this website to see the latest update on this EoI if any.

#### V. SUBMISSION & OPENING OF QUOTATION:

1. The EoI documents along with relevant documents shall be signed by the bidder in all pages with official seal.

- 2. The EoI document along with relevant documents should be submitted in a sealed envelope super scribed with "EoI for Empanelment of Agency to supply food items" and sent to "Director, State Institute of Health & Family Welfare, Odisha, Unit-8, Nayapalli, Bhubaneswar12" by Registered/Speed post on or before **07.06.2023**.
- 3. Any EoI received after date line or any other mode except Registered/Speed post shall be summarily rejected.
- 4. Bid will be opened (date will be announced in the official website of this Directorate) in presence of the bidders or their authorized representatives who wish to be present at time of opening of bids.

#### VI. EVALUATION OF BID DOCUMENTS:

- 1. EoI documents received will be evaluated by the committee on the basis of eligibility criteria and technical capabilities of the bidder.
- 2. The bids shall be ranked keeping in view the marks obtained on a scale of 100 marks during evaluation of bids. The financial bids of only those successful bidders who obtain minimum 70% points i.e. 70/100 in Technical evaluation will be opened for further evaluation.
- 3. The work will be awarded to the bidder whose bid has been determined to be technically qualified in terms of Point '2' above and who shall offer the best menu (Quality & quantity and number of items) in the Annexure-III
