The waste paper and HMT Machine aluminum Plates shall have to be lifted from the premises of the Offset Printing Press, near Kharvela Bhawan, Unit-V, Bhubaneswar within a week from the date of award of contract. Before lifting the waste materials, the contractor shall weigh and shred the papers and aluminum plates inside the office premises of the press. The requisite/necessary payments shall have to be cleared by the vendor prior to lifting of waste materials.
- 2. No opportunity shall be given to the bidders to modify or withdraw the tender at any stage during the validity period. Tender received after due date, Incomplete tender and tenders submitted with qualifying conditions or with conditions at variance with the special as wells as general terms and conditions of tender are liable to be rejected.
- 3. Assignment of contract and/or sub-contract of this contract either in whole or in part are strictly prohibited. The Director, S.I.H & F.W, Odisha may at his discretion terminate the contract and forfeit the security deposit in the event parting of any interest, in assignment of and /or sub-contract of the contract, either in whole or in part by the tenderer, if and when the fact of such parting assignment and/or subletting comes to light.
- 4. The tender is on the basis of "as is where is". Delivery shall be made and lifted by the tenderer at his own cost. Weighing and shredding shall be done by the vendor in the press premises before loading in front of the Superintendent of the Press, the cost which shall be borne by the Vendor.
- 5. The interested bidder should be furnished EMD of Rs. 5000/- in shape of DD favouring "Director, SIH & FW, Odisha" payable at Bhubaneswar. No interest shall be paid on the EMD.
- 6. The EMD submitted by the successful bidder shall be converted into performance guarantee deposit which shall be returned after completion of whole contract without interest.
- 7. If the Successful bidder abandons the contract, his earnest money shall be forfeited.
- 8. The contract will be awarded to the successful highest bidder (H1) in case the successful bidder does not lift the item mentioned within the stipulated period given in the work order, the PG deposit shall be forfeited and the contract will be awarded to the 2nd highest bidder subject to condition that the 2nd highest bidder agrees to the rate quoted by the highest bidder. Further, penalty of Rs. 500/- per day shall be imposed on the defaulting party, form the day of default till the day the contract is awarded to the 2nd highest bidder.
