- 2) **The bids must be accompanied by EMD/Bid Security and cost of Bid Document as mentioned for the specified work in Col-6 and 7 respectively of above table by online as per e-procurement guidelines.**
- 3) Availability of Tender for **On-line** bidding:- from **10.00 A.M. of 16.05.2023 to 5.00P.M. of 25.05.2023** from Govt. web site [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in).
- 4) If the rate quoted by the bidder is less than 15% of the tender amount, then such a bid shall be rejected and the tender shall be finalised basing on merits of rest bids. But if more than one bid is quoted at 14.99% less (Decimals up to two numbers will be taken for all practical purposes) than the estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system, where all bidders/ their authorised representatives, the concerned Superintending Engineer and DAO will remain present (Vide Office Memorandum — 12366/W dated.08.11.2013

of Works Department, Govt. of Odisha).

5) In pursuance to the Govt. of Odisha Works Deptt. Office Memorandum No. 4559 dt: 05.04.2021, Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the APS in the rates as noted below.

Exact amount of Additional Performance Security ( APS) in shape of Term Deposit Receipt pledged in favour of Superintending Engineer, Potteru Canal Division, M.V-79 / Bank Guarantee in favour of the Superintending Engineer, Potteru Canal Division, M.V-79 from any Nationalized / Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within 7 days of issue of letter of acceptance (LoA) by the Divisional Officer (By e- mail) to the successful bidder otherwise his/her bid shall be cancelled & he/she will be suspended for the time specified in the tender document.. Further, proceeding for blacklisting shall be initiated against the bidder. If the APS is submitted in shape of Bank Guarantee by the bidder, then the validity of the Bank Guarantee should be for a minimum period equal to the period allowed for completion of the work plus defect liability period of one year and one month extra for transaction period.

6) Bid must be accompanied with scanned copies of valid Registration Certificate duly registered in CDMS portal, active GSTIN, PAN Card and affidavit in support of their claim along with their bid failing which the bid will be rejected. Bidders registered as “Engineer Contractors” desirous to avail exemption of E.M.D. for participating in bid shall have to upload an affidavit for not having availed this facility in three works during the year 2023-24. In such case, the successful Engineer Contractor has to produce the original Registration Certificate for recording the fact of availing exemption of E.M.D. for award of the work. Bidders registered as S.C. & S.T. Contractors desiring to avail concession(s) / price preference as per prevailing rules should upload necessary document and affidavit in support of their claim along with their bid, failing which their case may not be considered for availing price preference as per the above rule. No claim in this regard after opening of the bid will be entertained.

7) Bid validity period of the Tender is for a period of 90 days from the last date of submission of Bid. Conditional bid is subject to forfeiture of EMD. If any bidder withdraws his Bid/Tender before the said

period or makes any modification in the terms and condition of the bid, the E.M.D. deposited at the time of submission of tender / bid shall stand forfeited.

8) No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an engineering department of the state Government is allowed to work as a contractor for a period of two years after his retirement from government service without government permission.

9) **The scanned copy of Registration Certificate duly registered in CDMS portal, active GSTIN, PAN card, Affidavits, No relation Certificate, No Litigation Certificate including all required papers should be uploaded in web-site and submitted at the time of online submission of Bid. The bidders have to furnish the original documents to the Superintending Engineer, Potteru Canal Division, MV-79, Dist: Malkangiri as and when required for verification. The successful bidder has to submit the original affidavit to the Superintending Engineer, Potteru Canal Division, M.V-79, Dist: Malkangiri before drawl of agreement. The bidder should mention his present Postal Address, e-mail id and Mobile Number in the Affidavit submitted with the tender.**

10) Exemption of EMD to the Engineer contractor will be allowed for a maximum of three works in a financial year and the fact of awarding a work with Exemption of EMD should be entered in the Original Registration Certificate of the Engineer Contractor. Engineer contractor desirous of availing the exemption of E.M.D. is required to submit an affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year.

11) Date of opening of Tender:- **Dated.26.05.2023 at 11.00 A.M.** in the office chamber of the Superintending Engineer, Potteru Canal Division, M.V-79. If the office happens to be closed on the last date of receipt of documents and on the date of opening, it will be extended to next working day at the same time and venue.

12) **In case, if lottery is inevitable for finalization of the tender, then the tender accepting authority will finalize the tender through a transparent lottery system, which will be held in the office of the Superintending Engineer, Potteru Canal Division, M.V-79. The date and time of the lottery will be intimated to the qualified bidders through their 'e' mail ID and office notice board.**

13) The Superintending Engineer, Potteru Canal Division, M.V-79 may be contacted during office hours on any working days for any further clarification or online between 16.05.2023 10.00 A.M to 18.05.2023 5.00P.M.

14) The Authority reserves the right to reject/cancel any or all the tenders without assigning any reasons thereof.

15) The bidders are required to submit their valid mobile number and 'e' mail id in their original affidavit for all correspondences.

16) The bidders shall have to upload an affidavit in support of authenticity of documents/ credential accompanied with the bid failing which the bid will be rejected. The authority reserves the right to verify the authenticity of documents in case of any doubt or complain.
