Applications are invited from retired Government Group-C & D employees for their re-engagement in the Headquarters Establishment of Panchayati Raj & Drinking Water Department as Peon on a contractual basis against the vacant posts of Peon for a period of One year or till the vacancies are filled up on a regular basis, whichever is earlier.

The interested retired Group-C & D employees may submit their application as per **Annexure-I** latest by **12.07.2023**.

2. Number of Vacancies to be filled up – As per requirement.

3. Eligibility Conditions:

- i. Employees who have retired from Government service on attaining the age of superannuation and below the age of 65 (sixty-five) years have good service records and are physically and mentally fit shall be eligible for consideration for employment.
- ii. Employees against whom Departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during their service period will not be eligible for consideration.

4. Selection Process:

i. Selection will be made through the Selection Committee constituted for the purpose.

5. Tenure, Terms & Conditions:

- i. The re-engagement shall be made initially for a period of one year only or till the existing vacancies are filled up on a regular basis, whichever is earlier. The engagement shall be extended for the subsequent period, subject to satisfactory performance.
- ii. The re-engagement employee will be entitled to consolidated remuneration as per the provision contained in Finance Department O.M No.24533/F, dated.29.09.2022.
- iii. The re-engagement employee will be governed by the provisions of Odisha Government Servants Conduct Rules, 1959, and shall be liable to be proceeded against for their misconduct omission and commission as per the



provisions under the Odisha Pension Rules, 1992.

iv. The appointing authority reserve the right to terminate the engagement at any time without showing any reason thereof. If the engagement officer desires to resign, he shall do so by giving one month's written notice to the competent authority.
