- 5. Bids received online shall be opened at 11.00 Hours on 09.08.2023 in the office of the undersigned in presence of the bidders who wish to attend. Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 6. The bidder shall transfer online the cost of bid document for Rs.4000/- towards cost of the Bid & Bid security mentioned in col-5 above through a process as mentioned under DTCN.
- 7. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.
- 8. Bidders are to submit only the original BOQ uploaded by publisher after entering the relevant fields without any alteration / deletion / modification .Multiple BOQ submission shall lead to cancellation of bid.
- 9. If the rate quoted by the bidder is more than 14.99 % less of the tendered amount then such a bid shall be rejected.

- 11. The authority reserves the right to reject any or all Bids without assigning any reason thereof.
- 12. In case of the lottery required to be conducted among the successful bidder in accordance with the Works Deptt.
