The Bids should be submitted by the eligible class / grade of contractors, registered with the State Governments / Central Government / M.E.S./ Railways, through On-line in the Government web-site <a href="https://www.tendersodisha.gov.in">www.tendersodisha.gov.in</a> The bidders should have necessary portal enrolment (with own digital signature certificate). The proof of registration from the appropriate authority shall be enclosed along with the bid. The registered bidders outside of Odisha State can also participate in this on-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with the appropriate authority of the Odisha State Government within one month of acceptance of bid.

- 3. Additional Performance Security:- If the amount quoted by the bidder is more that 15% less than the tendered amount, then such bid shall be rejected and tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system in presence of all the bidders/their authorized representatives which will be held in the office of Superintending Engineer, Burla Irrigation Division, Burla in presence of all bidders/their authorized representatives, the Superintending Engineer and Sr.DAO. Hence, all the bidders can enquire in the office of the undersigned regarding lottery before scheduled date as no further correspondence to the bidders in this regard will be made. In the event of the specified date for drawal of lottery being declared a holiday for the office inviting Bid, lottery will be drawn at the appointed time on the next working day.

Further proceeding of blacklisting shall be initiated against the bidder as per Works Department Memorandum No. 14299 dt. 03.10.2017 and Amendment made vide Office Memorandum No. 14459 dt. 20.09.2018. The time period of such APS deposit must be more than the duration of work.

- 4. Initial Security Deposit @ 2% of contract value shall be furnished by the bidders / bidder in shape of Term Deposit Receipt of Nationalized Bank pledged in favour of Superintending Engineer, Burla Irrigation Division, Burla.
- 5. Goods and Service Tax (GST) shall be applied as per prevailing rules or as amended from time to time.

- 9. Bid documents consisting of qualification, information and eligibility criteria of bidders, plans, specification and schedule of quantities of the work are available in web-site <a href="www.tendersodisha.gov.in">www.tendersodisha.gov.in</a> and the set of terms and conditions of contract and other necessary documents can be seen in the web-site till last date of sale and receipt of tender papers. Interested biders may obtain further information at the web-site <a href="www.tendersodisha.gov.in">www.tendersodisha.gov.in</a>.
- 10. The bid validity period of the tender is for a period of 90 days from the last date of receipt of the bids. If any bidder/tenderer withdraws his bid/ tender before the said period or makes any modification in the terms and conditions of the bid, the Earnest Money Deposit (EMD) deposited at the time of submission of tender shall stand forfeited.
- 11. No Engineer of Gazzetted rank of other Gazzetted Officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor till a period of two years after his/her retirement from Government Service without Government permission.
- 12. Other details including details of Portal Registration, Submission of Bid, Resubmission and withdrawal of bid can be seen in the bidding document which is available in web-site <a href="www.tendersodisha.gov.in">www.tendersodisha.gov.in</a>.
- 13. The bidders are indispensably required to submit the Original Copies of Valid Licence / PAN CARD / GSTIN Registration Certificate / Original Affidavit and authentic proof documents towards purchase of bid documents / tender papers within 07 (Seven) days from the date of opening of the Bid otherwise the bid shall be considered as non responsive, hence liable for rejection. Engineering contractors who are desirous availing the facility of exemption of EMD is required to submit the affidavit in original to the effect that he has not yet availed the facility for more than 03 (Three) works during the current financial year. Name of the works and authority to whom the tenders has been submitted must be mentioned in affidavit, failing which, the tender will be liable for rejection. However the original registration license of the Engineering contractor should be produced at the time of opening of tender.
- 14. If the 1<sup>st</sup> lowest bidder does not turn up for agreement after finalization of tender, then he shall be debarred from participation in bidding for three years and action will be taken to blacklist the contractor.
- 15. The bidders shall furnish an affidavit at the time of submission of the bid, about the authentication of the tender documents including Registration Certificate, PAN Card, Valid GST clearance certificate and security etc. failing which the bid shall be considered as non-responsive and thus liable for rejection. No adjustment of EMD will be entertained at all under any circumstance. Labour license is to be produced by the successful bidder at the time of agreement.
- 16. Amendment to Para 3.5.18 of OPWD code Vol-I & rule-29 of Appendix-IX of OPWD code Vol-II "The single tender received in 1st call shall be cancelled without opening of the bid & fresh tender will be invited" as per Office Memorandum No. 16 dated. 01.01.2015 of Works Department Govt. of Odisha and as per "Works Department O.M. No. 16, dated. 01.01.2015 implies that single tender received in the first call shall be cancelled without opening of bid and in case when more than one tender have been received in the first call and only a single tender is found to be responsive, the same is also liable to be cancelled due to lack of competitive price bidding. (Vide Letter No. 4410 dt. 19.02.2018 of DoWR & Memo No. 4714 dt. 13.02.2018 of the E.I.C., W.R., Bhubaneswar.
- 17. The bidder should mention his/her valid E-Mail Address / Phone No. in the separate sheet for communication regarding the tender. The date of time of the lottery if required will be intimated to the qualified bidders through their valid E-Mail Id / Contact Number provided in the tender website.

- 18. All the existing provision of OPWD Code with amendment from time to time will be applicable is deciding the tender. All correspondence regarding the tender process will be communicated by valid E-mail address provided in the tender website. All bidders are requested to check their E-mail from time to time regarding the tender. No claim whatsoever will be entertained for non-receipt of communication in hard copy.
- 19. Agreement shall be drawn only after due verification of ISD & APS of the successful bidder. If any fake documents are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for black listing through the license issuing authority.
- 20. As Goods and Service Tax has come into force with effect from 01.07.2017, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act-2017.

- 22. Bids received online shall be opened in the office of the undersigned on dated. 14.07.2023 at 11.00 A.M. If the office happens to be closed as specified, the bids will be opened on the next working day at the same time and same venue.
