

**Minutes of the Meeting held on 17<sup>th</sup> May 2023, convened by SE, R&B Keonjhar Division  
for discussion on the queries by the bidders w.r.t. the Empanelment of Design and  
Technical Agency (DTA)**

A Technical/Consultant Evaluation Committee (TEC) meeting was held under the convenorship of SE, (R&B) Keonjhar division (Nodal Authority) on 17<sup>th</sup> May 2023 to re-evaluate the 03 (Three) numbers of bids submitted by the respective bidder who has raised queries against their disqualification in the Preliminary Evaluation (1<sup>st</sup> Stage) w.r.t. Request for Qualification (RFQ) no. SE-PWD-K-01/2022-23 floated by the Nodal Authority on 01.02.23. The RFQ was also followed by corrigendum no. G-2/1294, dated 09.02.2023, Clarification to pre bid queries, dated 21.02.23 and corrigendum no. G-2/1957, dated 13.03.2023.

At the onset Superintending Engineer, Keonjhar (R&B) division (Nodal Authority) welcomed all the participants and briefed that the meeting has been called to re-evaluate the preliminary evaluation (1<sup>st</sup> stage) criteria of the concerned 03 (three) bidders (mentioned below) received for the RFQ no. SE-PWD-K-01/2022-23. The Nodal Authority mentioned that these bidders have raised queries w.r.t their disqualification in the preliminary evaluation (1<sup>st</sup> stage) upon the information supplied to them by this office via email dated 05.05.23 and as per the decision taken by the TEC in the meeting (ref. 2). The TEC then looking at the queries called the bidders in the chamber one by one for discussion and clarification of which the details are annexed below (Annexure I).

The TEC after having a careful observation on the queries raised by the respective bidders unanimously decided that HLL Infratech Services Ltd.' to be disqualified for the submission of multi bid document with EMD which aren't part as per reference from RFQ (Section no.12, evaluation proposal) and as per the procedure for submission of proposal, a single sealed envelope has to be submitted carrying technical proposal (Original) and financial proposal (Original), Page-15 (Section No-10, Submission of proposal). 'S & J Associates' to be disqualified on the ground of not submitting the document of ITR for the FY 2021-22 and financial Information provided in 'Tech 3' is incorrect for all years w.r.t the supporting documents. Further, TEC mentioned that bid documents of 'M/s Space Arch' and 'M/s Space Arch & M/s Collage Design Pvt. Ltd. (JV)' to be evaluated on the ground of minimum eligibility criteria of undertaking for application assignment as per RFQ (Ref- Tech 8, page no.59 Sub-

Clause-i. 'An applicant can submit its application for one or multiple categories'). The Annexure-I was also counter signed by the representative of the respective bidders accepting the decision of TEC on the day of 17<sup>th</sup> May 2023 in the office chamber of SE, R&B Keonjhar Division.

The TEC at the end mentioned that the committee will check the bids of 'M/s Space Arch' and 'M/s Space Arch & M/s Collage Design Pvt. Ltd. (JV)' only for Preliminary evaluation (1<sup>st</sup> stage) and Technical Evaluation (2<sup>nd</sup> Stage) and will take further course of action at the earliest.


