- 6. (i) Bidders have to remit their Earnest Money deposit/ Bid security and cost of Bid documents at Column 06 & 07 above in online mode. The bidders with pending or failure payment status shall not be able to submit their bid.
 - (II) Additional PERFORMANCE SECUITY shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) as tabulated below.

Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
