### 6. Minimum Eligibility Criteria :-

- i) The manufacturer / Authorised Distributor should have successfully Completed & Commissioned similar type of work valuing not less than Rs.20.25 Lakh (30% of the estimated cost) in any one financial year during the last 5 (five) years. However, in case of single work the contractor should have achieve the amount of Rs.20.25 lakhs (30% of the estimated cost) in 3 years time. The firm shall have to submit the performance certificate of the works constructed by them for satisfactory performance from appropriate authority i.e., not below the rank of Executive Engineer /equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- ii) The Firms/Companies/Registered Contractors should have annual financial turnover of not less than **Rs.27.00 Lakh (40% of the estimated cost)** in any one year in similar type of **Works** during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding years.
