15. As per O.M No 1499 dated 01.02.2023 of works Department, Government of Odisha "Security for the due fulfilment of a contract should invariably be taken. The security may be taken in shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal towards E.M.D/initial Security Deposit/ any other security deposit from the contractor or supplier." And the same may be pledged in favour of the Superintending Engineer, M.I Division, Kalahandi within 7 (Seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder.
16. If more than one bid will be 1<sup>st</sup> lowest the tender and quoted 14.99% less, will be decided through a transparent lottery system in presence of the bidders or their authorized representative.
17. The estimated cost put to tender is exclusive of GST as applicable.
18. Affidavit and supporting documents towards claim of exemption of EMD, price preference etc should be uploaded along with the tender documents failing which such claim shall not be considered.

19. The intending bidders should visit the work site before tendering and should be prepared with required machineries for earth work and concrete work to complete the work by the scheduled period of completion.
20. The intending bidders are required to furnish their valid e-mail address and cell phone number so as to inform them anything relating to tender which is mandatory.
21. Time is the essence of the contract and extension of time may not be allowed. Penalty will be imposed as per Agreement condition if the work is not completed within the stipulated period or not in proportion to the work programme.
22. The tender/tenders, where all technical qualified bidders for each package have quoted same rate at par with schedule of rates will be cancelled without any transparent lottery system as per Letter no. 7787 dated 31.05.2021 of Govt. of Odisha Works Department.
23. The cost of tender paper and EMD as indicated above shall be received online along with the bids as per guideline issued by Works Dept O.M No 6785 dated 09.05.2017 and No 17254 dated 05.12.2017. The Procedure of bid submission using electronic payment of tender paper cost and EMD by the bidder may be referred in Work Dept O.M No 17254 dated 05.12.2017 which has been added to the DTCN..

25. **The SC/ST contractors willing to avail 10% price preference should furnish the original affidavit during submission of bid.**
26. Technical Bids received through online shall be opened in the office of Additional Chief Engineer, KBK-I M.I. Circle, Bhawanipatna on **19.10.2023**.
27. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instrument is detected Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
