Additional Chief Engineer(T&C, STL)-cum-E.I., Bhubaneswar on behalf of Governor of Odisha invites online bids/ tenders from eligible reputed, ISO Certified Electrical Testing Equipment Manufacturers or their authorized distributors /dealers in double cover system for supply of electrical testing equipment to Standard Testing Laboratory at Bhubaneswar including their installation & commissioning under terms and conditions contained in the bid document.
2. Bid document consisting of technical specifications, schedule of quantities (Bill of Quantities- BOQ), terms and conditions of DTCN and other necessary documents together with procedure for on-line bidding can be seen in the website: <https://tendersodisha.gov.in>.
3. The Bid document will be available in the website: <https://tendersodisha.gov.in> from **10.00 A.M. of dt.16.09.2023 to 5.00 P.M. of dt.07.10.2023** for online bidding.
4. The bidder must possess compatible & valid Digital Signature Certificate (DSC) of Class-III.
5. Bids shall be received "on line" only on or before **5.00 P.M. of dt. 07.10.2023**.
6. Bidders have to scan and upload copies of Demand Drafts (issued by any Nationalized/Commercial Bank) drawn in favour of **Additional Chief Engineer(T&C, STL)-cum-E.I., Bhubaneswar** payable at Bhubaneswar for the amount as per ANNEXURE-XV towards cost of bid document (non-refundable), failing which the bids will be rejected.
7. Bidders have to scan and upload copy of Bid Security/ Earnest Money Deposit as per ANNEXURE-XVI in any one of the forms specified in bid documents pledged in favour of **Additional Chief Engineer(T&C, STL)-cum-E.I., Bhubaneswar**, failing which the bids shall be rejected.
8. The bidders have to submit original financial instruments towards cost of bid document and bid security/ Earnest Money Deposit and other documents as per clause-8 of DTCN to **Additional Chief Engineer(T&C, STL)-cum-E.I., Bhubaneswar** during office hours on working days from **11.00 A.M. of dt.09.10.2023 to 3.30 P.M. of dt.10.10.2023**, failing which the bids shall be rejected.
9. Bids received online shall be opened at **04.30 P.M. on dt.10.10.2023** in the **Office of the Chief Engineer (T, L & EC)-cum-CEI, Odisha, Bhubaneswar**.
10. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the stipulated date of opening of bids (technical) is declared Government holiday, the bids will be opened on the next working day at the same time and venue.
11. Time period for completion of supply including installation, testing & commissioning of electrical testing equipment shall be **90(Ninety) Days** from the date of issue of supply order. Other details can be seen in the bid documents.
