1. The Superintending Engineer, M.I. Division, Nayagarh on behalf of Governor of Odisha invites **percentage rate bids in single cover system only in 'ON LINE'** mode for works detailed in the table from **"D" & "C" Class Contractors** registered with the State Government and contractors of equivalent Grade/Class registered with Central Government /M.E.S/ Railways for execution of civil works on production of definite proof from the appropriate authority. The bidders may submit bids for any or all of the following works.

2. Bid documents consisting of plan, specification, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the website: www.tendersodisha.gov.in.
3. Bids must be accompanied by a non-refundable fee as indicated at Column-6 of Annexure towards cost of Tender Paper for the works. The cost of Tender Paper is to be remitted online as per instruction issued in Works Department office Memorandum No. 17254 dated 05.12.2017. Scanned clear copies should be uploaded. The Bidder desire of hire machineries or equipment from outside the state or owned but deployed outside the state are required to furnished 2% of the amount put to tender as bid Security. Only those bidders who successfully remit their cost of Tender Paper on submission of bids would be eligible to participate the tender/ bid process. The bidders with pending of failure payment status shall not be able to submit their bid. Tender inviting authority, State Procurement Cell, NIC the designated Banks shall not be held responsible for such pendency or failure.

4. Bidding documents can only be available on-line in the Government of Odisha website <http://www.tendersodisha.gov.in> from **31.08.2023** to **07.09.2023** up to **17.00 hours** for preview, download & submission.
5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class -I & Class-II.
6. Bids received online shall be **opened at 11.00 Hours on 08.09.2023** in the office of undersigned in presence of the bidders who wish to attend. Bidders who participated in the Bid can witness the opening of Bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. A bidder shall not be permitted to bid for works in the M.I. Organization responsible for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer & Junior Engineer (both inclusive).
8. The online bidders should upload the scan clear copy of the affidavit in support of correctness or proof of the information submitted including Bid Security Declaration accompanied with tender by them.
9. Engineer Contractor desires to avail the facility of exemption of E.M.D is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current calendar year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing which he will be not entitle to get any facility. Similarly ST/SC contractors seeking exemption of 50% E.M.D or price preference required to produce an affidavit to this effect. The ST / SC contractors having Degree/ Diploma in engineering are not allowed to avail both the benefits. **Both Engineering and ST / SC contractors should submit the affidavit in writing regarding the facility to concerned Officer inviting tender, otherwise they will not entitle to get the facility.**
10. If the rate quoted by the bidder is less than 15% of the amount put to tender, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But, If more than one bid is quoted (decimal up to two numbers will be taken for all practical proposes) either at the estimated cost put to tender or less than the estimated cost put to tender, the tender accepting authority will finalize the tender through a **transparent Lottery system on dated 22.09.2023 at 11.00 AM**. The cases of the eligible price preference bidders will also be decided accordingly.
11. **Additional performance security (APS)** is being obtained from the Successful Bidder when the Bid amount is less than the estimated cost put to tender to the extent of exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount in shape of N.S.C/Postal Saving Bank Pass Book / K.V.P / Post Office Term deposit receipt / Deposit receipt of any Nationalized /Schedule Bank duly pledged in favour of the Superintending Engineer, M.I. Division, Nayagarh **within seven days of issue of Letter of Acceptance (LoA) by the Divisional Officer (by e-Mail)** to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. **Further proceeding for blacklisting shall be initiated against bidder.**

The State Government have been pleased to fix the following rate of Additional Performance Security.

12. Goods and Service Tax (GST) will be imposed as applicable.
13. Any Corrigendum / Addendum will be displayed in website <http://tendersodisha.gov.in> only. It is the bidder's responsibility to verify the web site for latest information / corrigendum related to the bid.

14. Conditional tender will summararily be rejected.
15. The bidders subject to be disqualified, if they have record of poor performance, such as abandoning the work, not properly completing the previous contract with the organization in ordinate delays in completion other projects, litigation history or financial failures.
16. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of the registration as contractor including forfeiture of bid security deposited.
17. Quality control tests as per specification for all items of the work executed will be taken in nearly Govt. Quality Control Laboratories of Minor / Medium / Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect.
18. Scanned clear copies should be uploaded. Non-visible copies of Documents may be liable for rejection.
19. The works are very urgent in nature and contractor should draw the agreement after finalization of the tender without any delay.
20. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
21. The bidder must provide the mobile No, address with PIN No and e-mail ID along with the tender documents for any intimation regarding tender. (THIS OFFICE WILL NOT BE HELD RESPONSIBLE FOR NON INTIMATION DUE TO NON RECEIPT OF MOBILE NO/ Complete address with PIN No / e-mail ID OF BIDDER).
22. The bids for the works shall remain valid for a period of 90 days from the last date of receipt of bids. If any bidder / renderer withdraws his/her bid / tender before the said period or makes any modification in the terms and conditions of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
23. All the existing provisions of OPWD code with amendment from time to time will be applicable in deciding the tender. All correspondence regarding the tender process will be communicated by registered post/ e-mail address. All are requested to check the e-mail from time to time regarding the tender. No claim whatsoever will be entertained for non receipt of communication in hard copy.
24. Any modifications/additions to the above notice will be available in the portal www.tendersorissa.gov.in.
25. Authority will not be held responsible for system failure, malfunction of internet or traffic jam. Bidders are advised to submit their bids well in advance within the stipulated period.
26. Annexure appended in the technical bid documents should be filled up properly and uploaded in the website for evaluation of technical bid, otherwise the tender will not be considered.
27. The contractors R.C (Registration certificate), GST/GSTIN, PAN, Labour Licence as per govt. norms, No Relation Certificate, work not abandoned for last five year & Affidavit, the scanned certified copies of which have been submitted through web-site should be produced in original to Superintending Engineer, M.I. Division, Nayagarh for verification within 5 days of opening of technical bid.
28. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for two years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfills all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
29. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and incase failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
30. The authority reserves the right to reject any or all Bids without assigning any reason.
