The **Superintending Engineer**, **P.H. Division. Balasore** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Two Bid system (Part-I: General & Technical Bid and Part-II: Price Bid) from "**B" Class Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways having experience and expertise in Design, Construction, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P-1 Contract Form of Odisha PWD**. The bid should be submitted on-line in the website **www.tendersodisha.gov.in** by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State.

The Firms/ Companies/ Registered Contractors should have successfully Completed i) & Commissioned Works of similar type valuing not less than Rs.17.72 Lakh (30% of the estimated cost) in any one year during the last 5 (five) years. However, such similar type of work must cover at least one Elevated Service Reservoir or Ground Storage Reservoir of any capacity or laying of pipeline works. The firm shall have to submit the performance certificate of the works constructed by them for satisfactory performance from appropriate authority i.e., not below the rank of Additional Chief Engineer /Superintending Engineer/equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.

The Firms/Companies/Registered Contractors should have annual financial turnover of not less ii) than Rs.26.63 Lakh (40% of the estimated cost) in any one year in Civil Construction Works during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding

If the bid has been invited in a common notice for different works or tender invited iii) for different works in consecutive notice in a shorter time period, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

In such cases, the order of opening of the bids shall be that in which they appear in the 'Invitation for Bids'. Fulfilment of one's bid capacity and other eligibility criteria in any one or more bids (in seriatim) will make him ineligible for subsequent bids.

In case value of works executed in any one financial year is not available in the Certificates, the same shall be calculated on a pro-rata basis, considering that the total completed value and the time schedule in days.

The Bidder should have not been black listed by any Govt./ Govt. Undertaking on the bid 9. opening date. Self-declaration certificate by Bidder in the form of Affidavit is to be

submitted.
