8. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.

Bids received on line shall be opened at **11.00 Hours on 04/11/2023** in the office of the Superintending Engineer Cuttack (R&B) Division No.I, Cuttack in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
11. The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to avail the exemption along with bid document.
12. The ST/SC contractors willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document.
13. The implementation of GST rules by the Govt. of Odisha is to be accepted by the Bidder at any point of time.
