Superintending Engineer, Rural Works Division, Bhubaneswar on behalf of **Governor of Odisha** invites **percentage rate bids composite tender in double cover system through e-procurement for Building work for 2023-24 as per Annexure**. The bid should be submitted on-line in the website www.tendersorissa.gov.in by eligible class of contractors of Government of Odisha or of equivalent class of other State Government / Railways / CPWD / MES. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha, can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before award of the work.

1	E.M.D. required	:	The bidder shall transfer online the Earnest Money Deposit/Bid Security at the rate of 1% of the estimated cost put to tender as mentioned under DTCN. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the State are required to transfer online 2% of the amount put to tender as Bid Security. Exemption from EMD is permissible as per codal provisions of Govt. of Odisha.
2	Cost of tender paper	:	The bidder shall transfer online the cost of bid document for Rs. 10000/- towards tender costing over Rs. 50.00 lakh towards cost of Bid through a process as mentioned under DTCN.
3	Additional Performance Security	:	The successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost (mentioned below) as Additional Performance Security in shape of N.S.C / Post Office Savings Bank Account / Post Office Time Deposit Account / Kissan Vikas Patra / TDR / Bank Guarantee (BG) / e.BG (e. Bank Guarantee) pledged in favour of Superintending Engineer Rural Works Division Bhubaneswar within seven days from the date of intimation.

8. Bid documents consisting of qualification information and eligibility criterion of bidders, plans, specifications, drawings & the schedule of quantities of the various classes of work is available in website www.tendersorissa.gov.in
9. The rates quoted by the Contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to Contractor on each bill amount.
10. Prevailing rate of GST on the gross amount of the bill will be paid to the Contractor on Tax Invoice being raised by the Contractor.
11. The bid for the work shall remain open for acceptance for a period of ninety days from the Last date of receipt of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
12. A bidder shall not be permitted to bid for works in the R.W. Division, Bhubaneswar for award and execution of contracts in which his or his spouse's near relative (defined as first blood relations, and their spouses) is posted in the rank of Asst. Engineer & above in any Engineering Deptt. or in the rank of Under Secretary & above in any Public Works Deptt. Under Govt. of Odisha.
13. The contractor has to upload an Affidavit regarding correctness of all the document uploaded in the website.
14. If the rate quoted by the bidder is less than 14.99% of the tendered amount then such a bid shall be rejected & the tender shall be finalised basing on merits of rest bids. But, if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than estimated cost, the tender accepting authority will finalise the tender through a **transparent lottery system**, where all bidders/their authorised representatives, the concerned Superintending Engineer and DAO will remain present.
15. The Additional Performance Security of the amount of difference shall be imposed only on the successful bidder (in shape of **N.S.C / Post Office Savings Bank Account / Post Office Time Deposit Account / Kissan Vikas Patra, TDR / Bank Guarantee (BG) / e.BG of any scheduled Bank** pledged in favour of the undersigned), which is required to be provided before drawl of agreement, or else the bid of the successful bidder would be cancelled & the security deposited would be forfeited alongwith other action as per conditions of DTCN.
16. **The single tender received in the 1st call shall be cancelled without opening of the bid.**
17. The bid of any contractor whose tender has been rescinded or who has abandoned any work within 5 years will be rejected without showing any reason thereof. This provision should form a part of the affidavit submitted as per Clause No.-13 above.
18. If the Bidder fails to submit the original documents for verification within 5-days of opening of this tender, his bid security shall be forfeited and his portal registration shall be cancelled and his name shall also be informed to the registering authority for cancellation of his registration.
19. The Intending tenderers should have executed **similar nature of work i.e. similar to the items contained in the BoQ** duly certified by not below the rank of Superintending Engineer and equivalent worth 50% of the estimated cost put to tender during any three financial years taken together of the last preceding 5 years in case of contract spanning for more than one financial year the break up of execution of work in each of financial year should be furnished.
20. The Intending tenderers should have the total financial turn over of an amount not less than the amount put to tender during any three financial years taken together of last preceding five financial years duly certified by Registered Chartered Accountant (C.A.) firm.
21. The contractors should have furnished their E.I. license or lease deed for Sl. No. 1 of Annexure of TCN & both E.I. & P.H. license or lease deed for Sl. No. 2 of Annexure of TCN.

23. Employer shall not accept any responsibility for failures or breakdowns of the electronic procurement system during the e-tendering process. In case of such system failure, malfunction, or breakdown during the bidding process, an e-mail will be sent to all registered bidders or a notice will be published on the Employer's e-procurement portal notifying the specific changes(if any) on the key dates of tender as appropriate.


