The procurement office publishers, (office inviting the tender) or other concerned officers authorized to receive necessary original documents on behalf of the procurement officer publisher shall not be held responsible for any postal delay for non-receipt of the same within specified date & time. Only those bidders who successfully remit their cost of Tender paper and Earnest Money Deposit on online submission of bids would be eligible to participate in the tender/bid process. The bidders with pending or failure payment status shall not be able to submit their bid.
13. Bids must be accompanied with on line receipt of tender paper cost and EMD through e-procurement, Affidavit along with all tender documents specified for the work in the shape as detailed in the DTCN without which the tender is liable for rejection. No hard copy for payment of Tender paper cost and EMD will be accepted.
14. The authority will not be held responsible for any technical snag or network failure during online bidding, If the Office happens to be closed on date of opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
15. The bidder must possess compatible Digital Signature Certificate (DSC) of class- II or Class-III.
16. Bid received on line shall be opened in the Office of the Superintending Engineer, M.I. Division, Anandapur on **29.11.2023** at **11.00** AM.

In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of the APS in the rates as noted below In shape of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee duly pledged in favour of the Superintending Engineer, M.I.Division,Anandapur from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch /e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) etc. within seven days of issue of letter of acceptance(LOA) otherwise the bid shall be forfeited. Further, Proceeding for black listing shall be initiated against bidder as per Government of Odisha , Works Department Office memorandum -1499 dtd. 01.02.2023.**

20. **The SC/ST contractors willing to avail 10% price preference should furnish the original affidavit during submission of bid.**

21. Bid documents consisting of qualification information & eligibility criterion of the bidders, plans, specification, drawings & abstract of various classes of works is available in Website [www.tenderorissa.gov.in](http://www.tenderorissa.gov.in) during the bidding period.
22. 1% (one percent) of gross bill of the bidder will be deducted towards labour cess over and above the usual deduction.
23. If the rate quoted by the bidder is less than **15%** of the tendered amount, then such bid shall be rejected as per amendment to appendix-IX , clause-36 of OPWD code vol-II by inclusion.
24. The single valid tender received shall be cancelled without opening the bid in 1st call.
25. If two or more valid Tenderers are in equal quoted rate then transparent **lottery** will be held on dt. **04.12.2023** at **11.00** AM in the office of the Superintending Engineer, M.I.Division,Anandapur in the presence of Contractor or their authorized agents.
26. Submission of fake N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee shall be liable for rejection of Bids and criminal action shall be initiated against the concerned bidders. The agreement of the 1<sup>st</sup>.lowest bidder after transparent lottery shall be executed after necessary verification of N.S.C./ Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee from the concerned Bank/ Post Office.
27. The bidder shall have to furnish the No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Junior Engineer or above is related to him.
28. The intending bidders should offer their rates excluding GST. The GST as applicable for the work contract shall be paid over bill amount of the work at the time of payment of each bill..The amount put to tender is exclusive of GST.
29. OGST @ 1% & CGST @ 1% on the Gross amount of the bill shall be deducted from the contractor's bill as tax deduction at source (TDS). In case of interstate supply IGST @ 2% shall be deducted.
30. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor/Medium/Major Irrigation Organisation. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respect at his own cost.
