Bids received on line shall be opened at 11.00 Hours on 12/12/2023 in the office of the Superintending Engineer, Cuttack (R&B) Division No.I, Cuttack in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

The Engineer contractor willing to avail the Exemption of E.M.D will submit the scan copy of affidavit to avail the exemption along with bid document and the original affidavit will be submitted before opening of Bid. Affidavit should contain how many times such facility have been availed by him prior to this during the current financial year, otherwise they will not be entitled to avail such facilities.
- 11. The ST/SC contractors willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document and the original affidavit will be submitted before opening of Bid. Other wise they will not be entitled to avail such facilities.
- 12. The implementation of GST rules by the Govt. of Odisha is to be accepted by the Bidder at any point of time.
