#### 6. Minimum Eligibility Criteria :-

- The firm / Companies / registered contractor should have successfully Completed & Commissioned similar type of work valuing not less than Rs.32.30 Lakh (30% of the estimated cost) in any one financial year during the last 5 (five) years. However, such similar type of work must cover at least one of the single work. The firm shall have to submit the performance certificate of the works executed by them for satisfactory performance from appropriate authority i.e., not below the rank of Executive Engineer /Superintending Engineer / equivalent. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- The Firms/Companies/Registered Contractors should have annual financial turnover of not less than Rs.43.07 Lakh (40% of the estimated cost) in any one year in similar type of Works during last 5 (five) years and the turn over need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding years.

### 7. Escalation Factor (On Compound basis):

Following enhancement/compounding factors will be used for the costs of works executed and the financial figures to a common base value.

8. To arrive at the value of completed works, Value of multiple contracts executed in a financial year shall be considered. For this purpose, the Completion certificates given by the authorities for any one financial year shall be considered. In case value of works executed in any one financial year is not available in the Certificates, the same shall be calculated on a pro-rata basis, considering that the total completed value and the time schedule in days.

- The contractor whose contract has been rescind in any one or more work during last 9. 5(five) years can not participate in the tender. In support of that he has to submit a self declaration certificate in form of affidavit.
- The Bidder should have not been black listed by any Govt./ Govt. Undertaking on the bid 10. opening date. Self-declaration certificate by Bidder in the form of Affidavit is to be submitted.
- The bidder / contractor are bound to registered themselves in CDMS Portal developed 11. by State Procurement Cell, Odisha, Bhubaneswar. However, the successful out of state bidders those who are not registered in CDMS Portal, Odisha are bound to registered themselves before signing of the agreement.
