The Additional Chief Engineer, P.H. Division-Bhubaneswar Tender Inviting Authority (TIA) on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in single Bid system from **H.T. Electrical Contractor** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways having experience and expertise of Similar Type of Works and fulfilling minimum eligibility criteria as stated here under and other detailed qualifying requirements given in the DTCN to be eventually drawn up in the **Standard P₁ Contract Form of Odisha PWD**. The bid should be submitted on-line in the website www.tendersodisha.gov.in by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). Contractors registered elsewhere but not registered with Government of Odisha can also participate in the e-procurement after necessary enrolment in the portal but have to subsequently register themselves with the appropriate registering authority of the State Government before award of work / signing of the Agreement as per prevalent registration norms of the State.



Division, Bhubaneswar Odisha for verification within three days of opening of Bid. Otherwise the tender will be rejected.
