15. <u>As per O.M No 1499 dated 01.02.2023 of works Department, Government of Odisha</u> "Security for the due fulfilment of a contract should invariably be taken. The security may be taken in shape of N.S.C./ Post Oflce Savings Bank Accounl/ Post Office Time Deposit Account/ Kisan Vikas Patra./ Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal towards E.M.D/initial Security Deposit/ any other security deposit from the contractor or supplier." And the same may be pledged in favour of the Superintending Engineer, M.I Division, Jashipur within 7 (Seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder.

- **16.** If more than one bid will be ^{1st} lowest the tender and quoted 14.99% less, will be decided through a transparent lottery system in presence of the bidders or their authorized representative.
- 17. The Contractors who have more than three works pending under this Division and who has not completed the work in time and contract has been closed or recommended for closer with penalty under this Division at the time of bidding are not eligible to participate in the present tender.
- 18. The estimated cost put to tender is exclusive of GST as applicable.
- 19. Online payment of Bid cost & Bid security and uploading of valid RC, GSTIN & PAN, Affidavit in Annexure-E(1) and litigation in Annexure-E(2) as well as undertaking regarding no relation certificate as per Annexure-C(1) are mandatory without which the bid shall be treated as non-responsive.
- **20.** The intending bidders should visit the work site before tendering and should be prepared with required machineries for earth work and concrete work to complete the work by the scheduled period of completion.
- **21.** The intending bidders are required to furnish their valid e-mail address and cell phone number so as to inform them anything relating to tender which is mandatory.
- **22.** Time is the essence of the contract and extension of time may not be allowed. Penalty will be imposed as per Agreement condition if the work is not completed within the stipulated period or not in proportion to the work programme.
- **23.** The tender/tenders, where all technical qualified bidders for each package have quoted same rate at par with schedule of rates will be cancelled without any transparent lottery system as per Letter no. 7787 dated 31.05.2021 of Govt. of Odisha Works Department.
- 24. - 28. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instrument is detected Criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
