04. The last date and time of seeking clarification of the tender is **05.02.2024 up to 3.00 PM.**
05. The bidder must possess compatible Digital Signature Certificate DSC of Class II or Class-III.
06. Bids shall be received only “ONLINE” on or before **12.02.2024 upto 5.00PM**
07. The Bids received ONLINE shall be opened at **12.00 Noon onwards on dated 13.02.2024** in the office of the **Superintending Engineer (Civil), Ports & IWT, South Division, Berhampur** in the presence of bidders who wish to attend. Bidders, who participated in the bid, can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
08. The ST/SC contractors willing to avail the facilities as fixed by Govt. Will submit scan copy of the Affidavit for the same alongwith tender documents;
09. Engineering contractors desirous to avail EMD exemption have to submit affidavit with uploading the same in e-portal tender declaring therein to the effect that they have not yet availed **EMD exemption during the financial year 2023-24**, as per works Department Office Memorandum No.12914 Dtd.23.08.2018 otherwise they will not be entitled to avail such facilities.
10. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. The successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) at following rate as per O.M.No.4559 Dated. 05.04.2021 of works Department Govt. of Odisha.

The Additional Performance Security (APS) shall have to furnish in shape of N.S.C/Post Office Savings Bank Account/ Post Office Time Deposit Account/ Kisan Vikash Patra/ Bank Guarantee in favour of the Divisional Officer from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/ e-Bank Guarantee executed on the National e-Governance Services Limited (NeSL) Digital Document Execution Portal within seven days of issue of letter of Acceptance (LoA) by the Divisional Officer (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money Deposit/Bid Security shall be forfeited. Further, processing for blacklisting shall be initiated against the bidder.


