CORRIGENDUM

- 3. The category of service (Column No.2) mentioned at Point No.2.2 (Sl.No.5) of the R.F.P., may be read as "Watching" instead of "watch and Ward". Similarly the category of services (Column No.2) mentioned at Point No.2.2 (Sl.No.9) may be read as "Night Watching" instead of "Protection and safeguarding".
