The Bids received ONLINE shall be opened at 12.00 Noon onwards on dated 20.01.2024 in the office of the Executive Engineer (Civil), Ports & IWT, South Division, Berhampur in the presence of bidders who wish to attend. Bidders, who participated in the bid, can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 08. The ST/SC contractors willing to avail the facilities as fixed by Govt. Will submit scan copy of the Affidavit for the same alongwith tender documents;

Engineering contractors desirous to avail EMD exemption have to submit affidavit with uploading the same in e-portal tender declaring therein to the effect that they have not yet availed 2 (two) nos. of EMD exemption during the financial year 2023-24, otherwise they will not be entitled to avail such facilities.
